### 1) Mode of Payment:

The payment should be made through online mode only by visiting the link provided for Payment under Online payment on CIDCO website https://cidco.maharashtra.gov.in. Observance of payment schedule is an essence of the contract.

### 2) Extension of time:

Payment of Installments: The Corporation may in deserving cases, extend the period determined in the scheme for payment of installments which shall not exceed Six Months in all. For extended period, Delayed Payment Charges at the rate as may be fixed by the Corporation by a general or specific order, shall be payable by the allottee along with next due installment. At present Delayed Payment Charges are @ 12% upto 3 months and 16% beyond 3 months for the extended period.
