

### Justification for price / rate

As far as Market Value in Index II is concerned, it is not possible to comment on same, may be government rates are fixed by sampling during same point of time in part and whereas, Market values change every month.










# Route Map of the property Site u/r

Note: The Blue line shows the route to site from nearest railway station (Nashik Road – 5.4 Km.)







