- You shall comply with provision of tree plantation again for accupancy.
- You shall develop the undeveloped RG & proposed RG submitted by the architect before seeking Full Occupancy.
- 7. You shall make arrangement of sufficient quantity of potable water and continuous supply of electricity to prospective residents of the buildings
- 8. Provision of infrastructure by CIDCO cannot be made immediate the tank one, it shall be responsibility of the applicant to make arrangement of all infrastructure including disposal of sewage, solid waste etc. at his own cost.
- Any alteration/addition or change in user in future carried but without fries approach CIDCO shall be treated as unauthorized and liable for actions mentioned under section 53 mm MR&TP act, 1966.
- 10. All the conditions mentioned in Environment clearance dated 2 06/2016 shall be binding on you.
