








# Route Map of the property site u/r

Note: The Blue line shows the route to site from nearest Railway station (Nashik – 15.2 KM)








- 3. A valuer shall endeavour to ensure that he/it provides true and adequate information and shall not misrepresent any facts or situations.
- 4. A valuer shall refrain from being involved in any action that would bring disrepute to the profession.
- 5. A valuer shall keep public interest foremost while delivering his services.

## **Professional Competence and Due Care**
