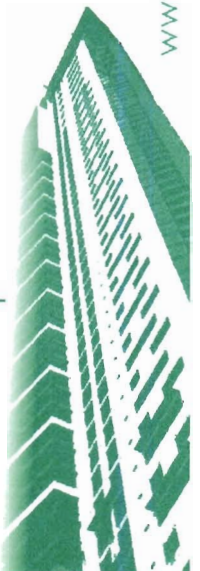

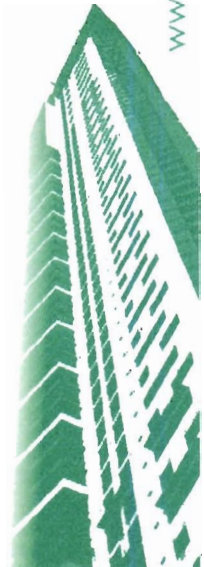

As the property is a Commercial unit, we have adopted Sale Comparison Approach Method for the purpose of valuation .The Price for similar type of property in the nearby vicinity is in the range of ₹ 27,000.00 to ₹ 27,000.00 per Sq. Ft.
