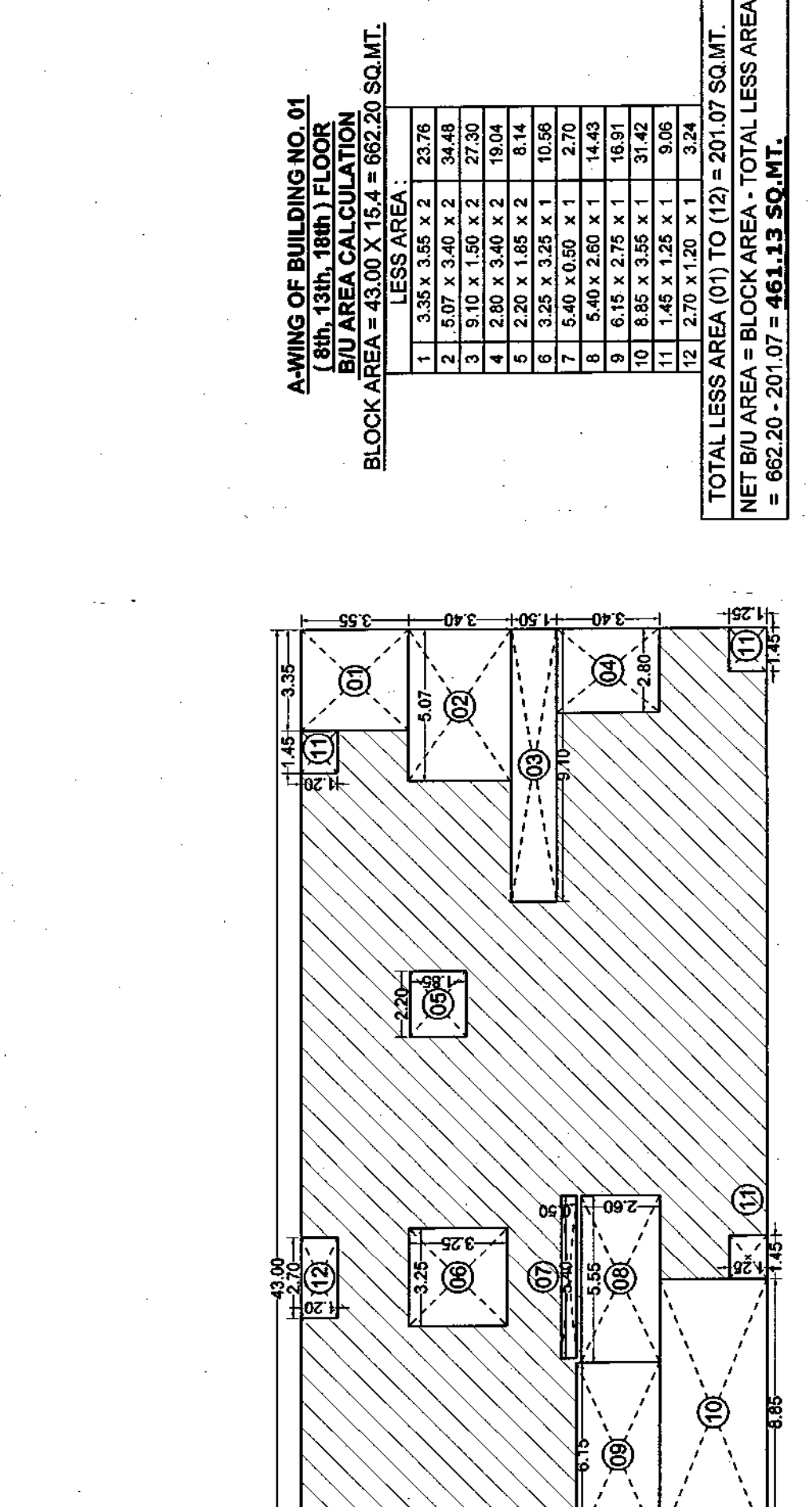

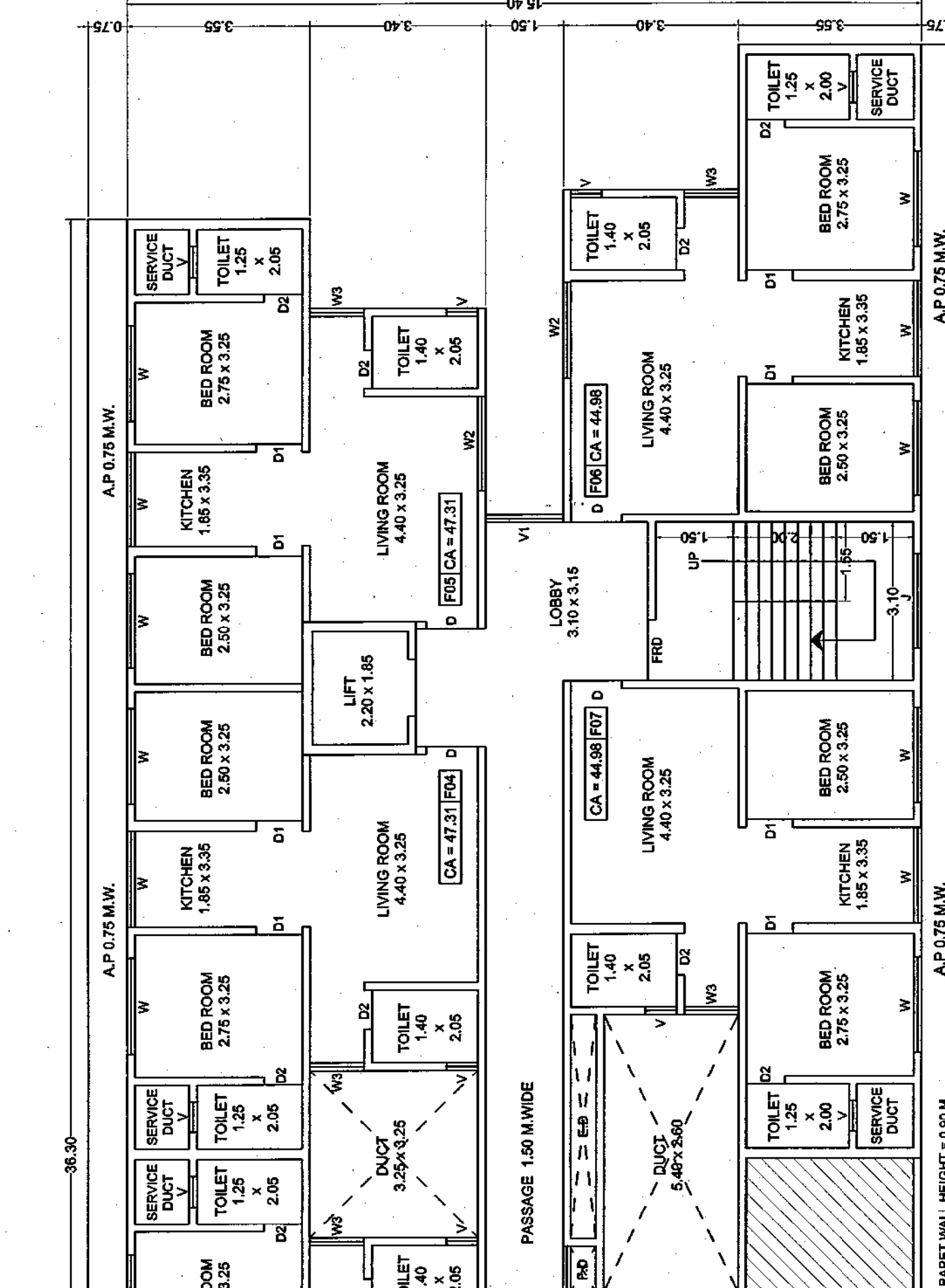

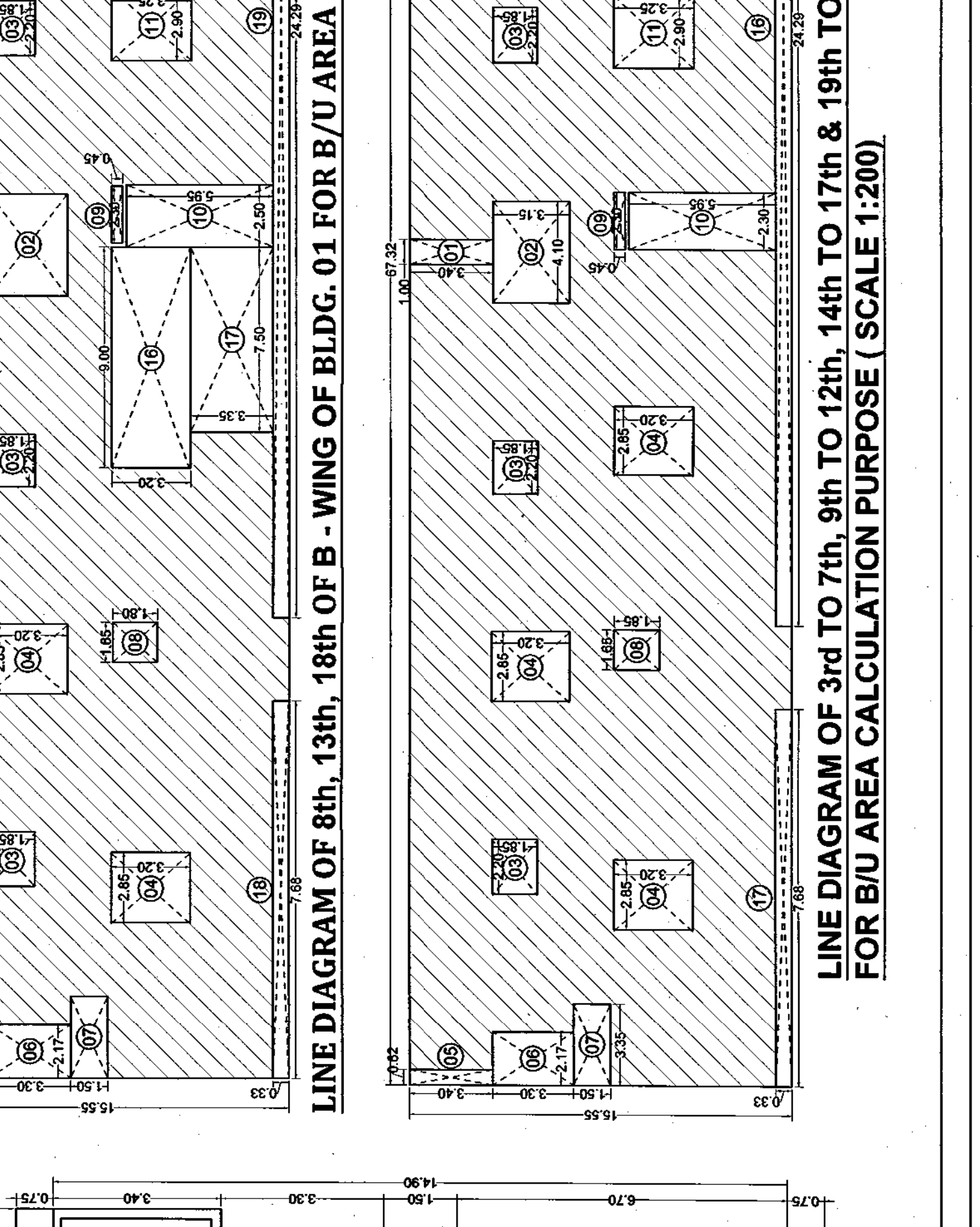

8th, 13th, & 18th FLOOR PLAN OF A - WING OF BLDG NO. 01

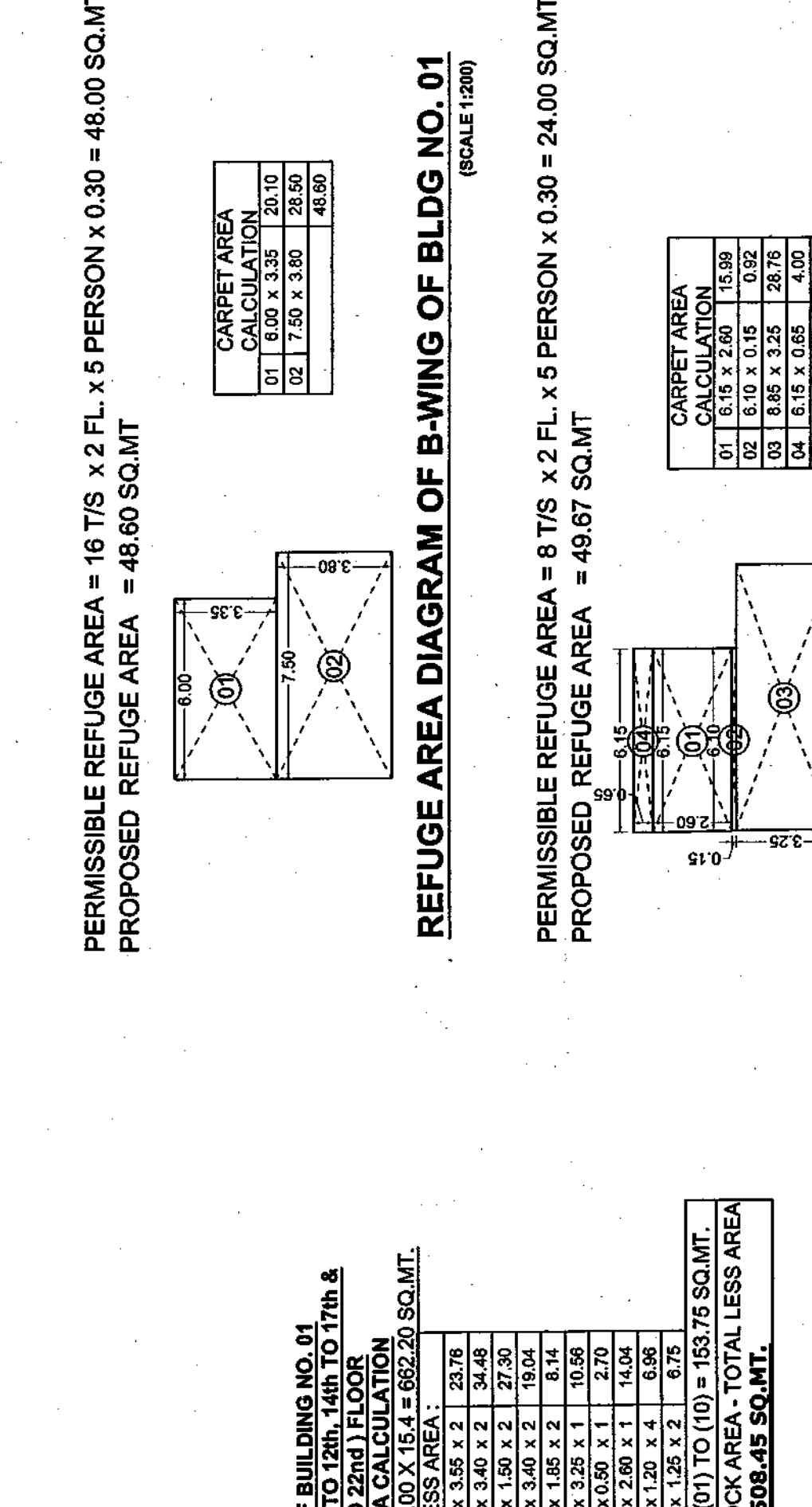

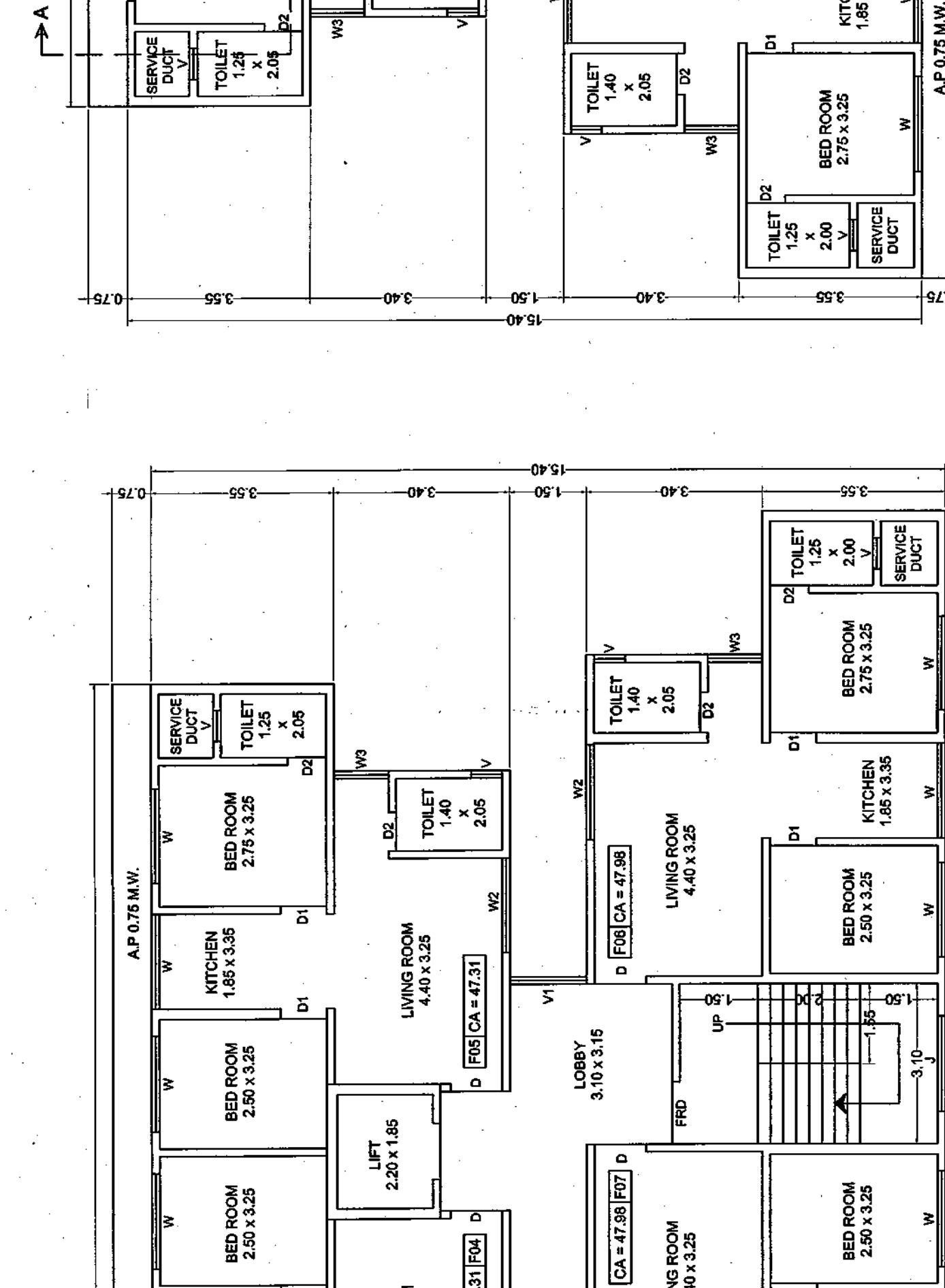


3rd to 7th, 9th to 12th, 14th to 17th, 19th to 22nd FLOOR PLAN OF B - WING OF BLDG NO. 01

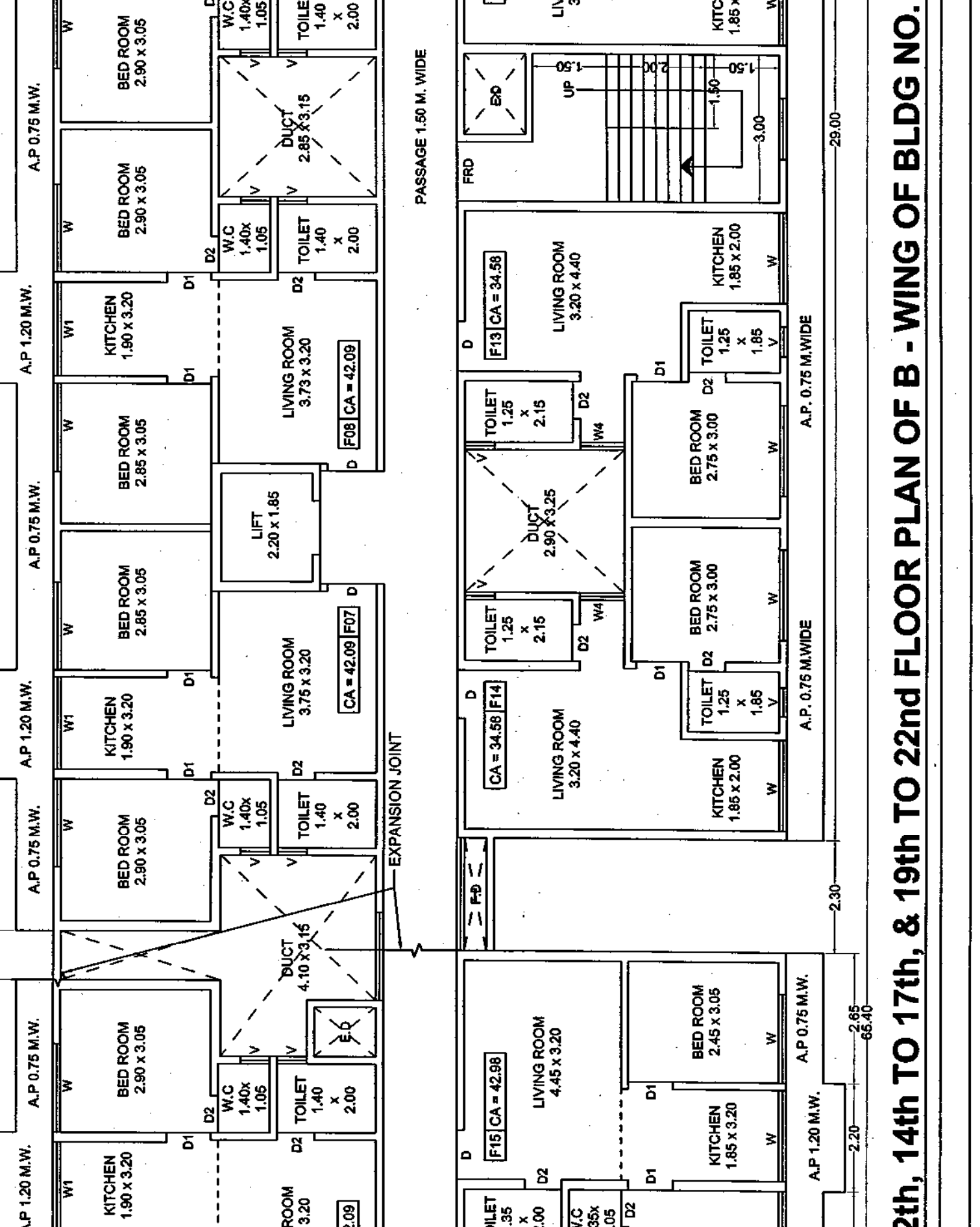

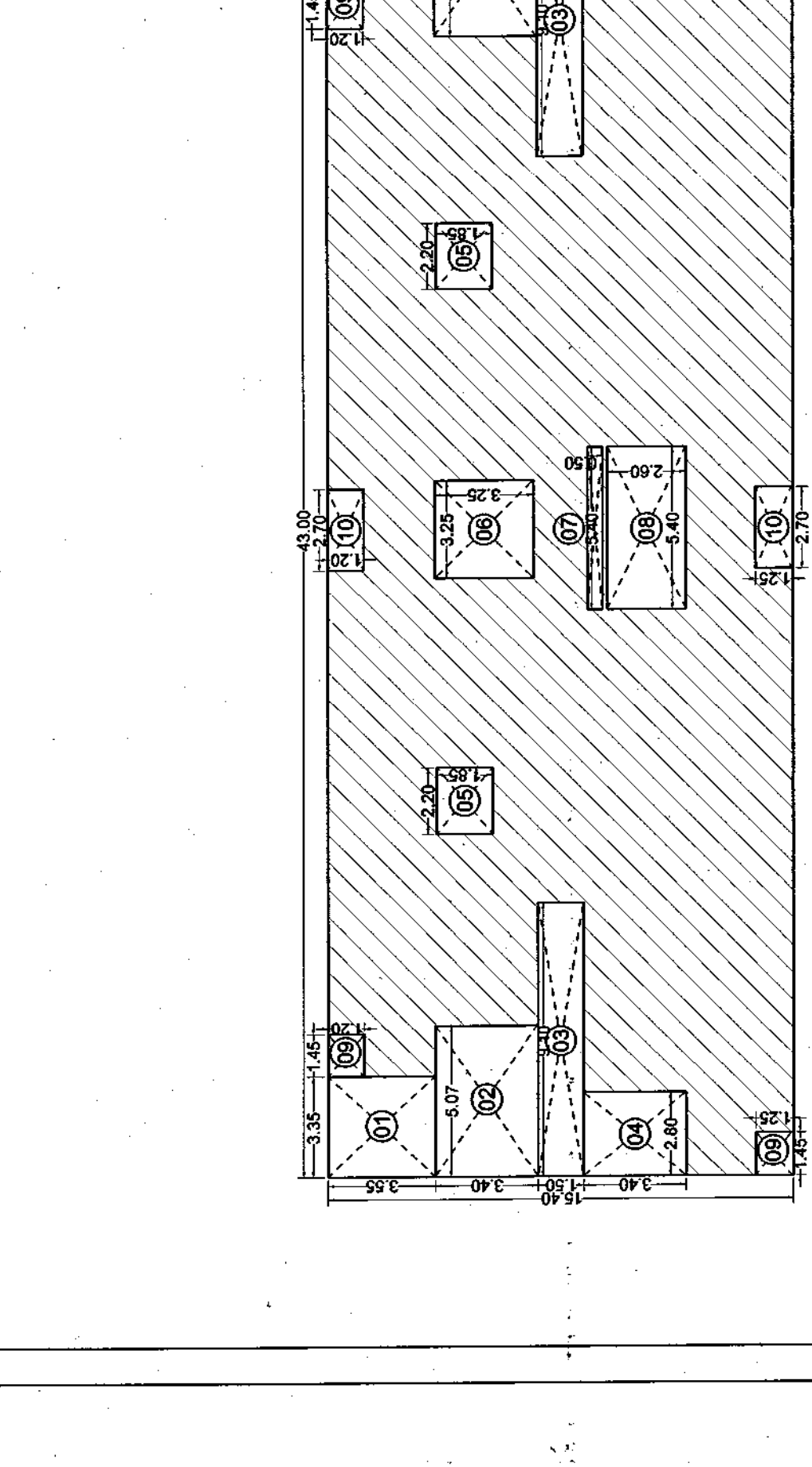

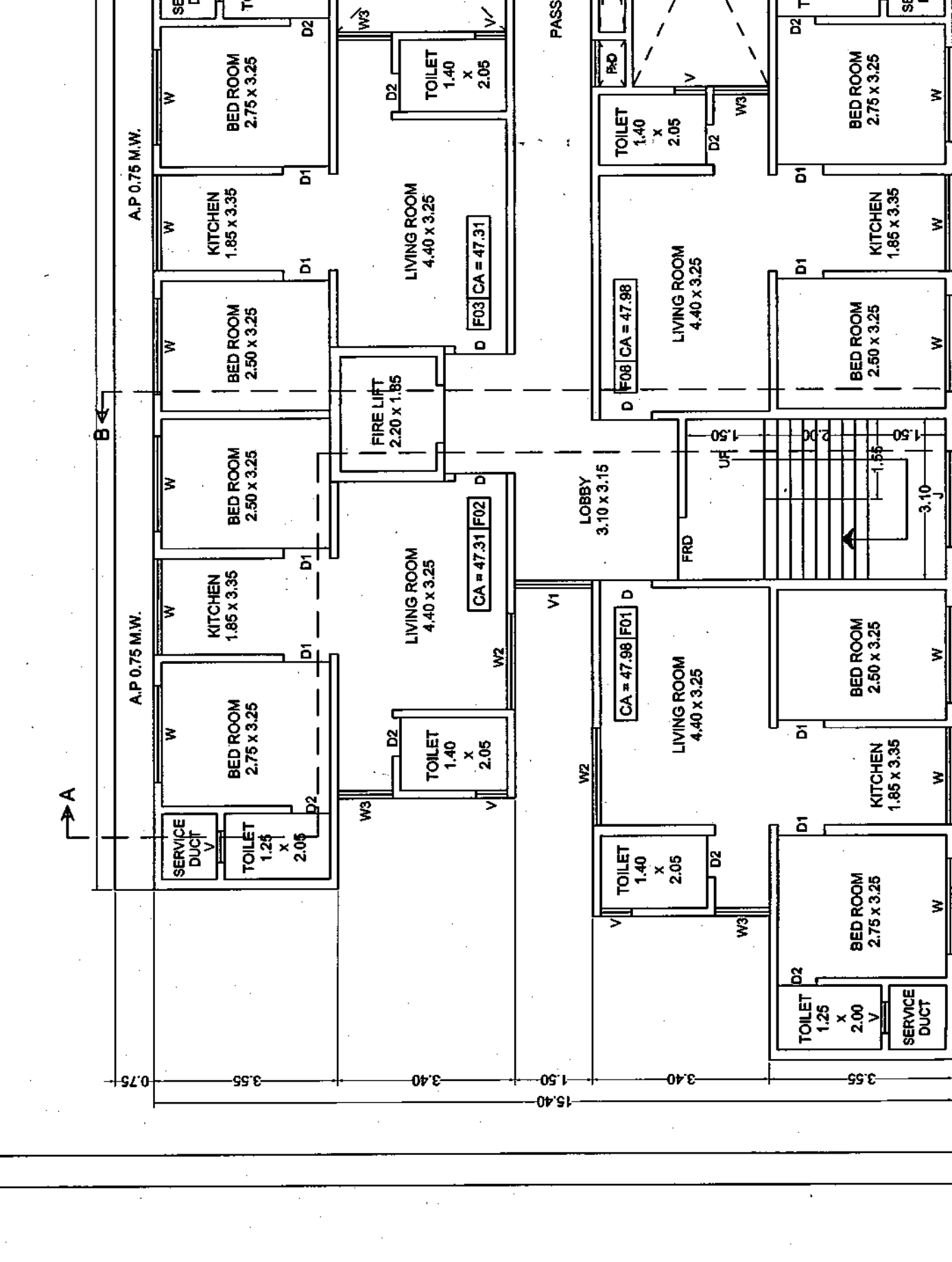


8th, 13th, & 18th FLOOR PLAN OF B - WING OF BLDG NO. 01

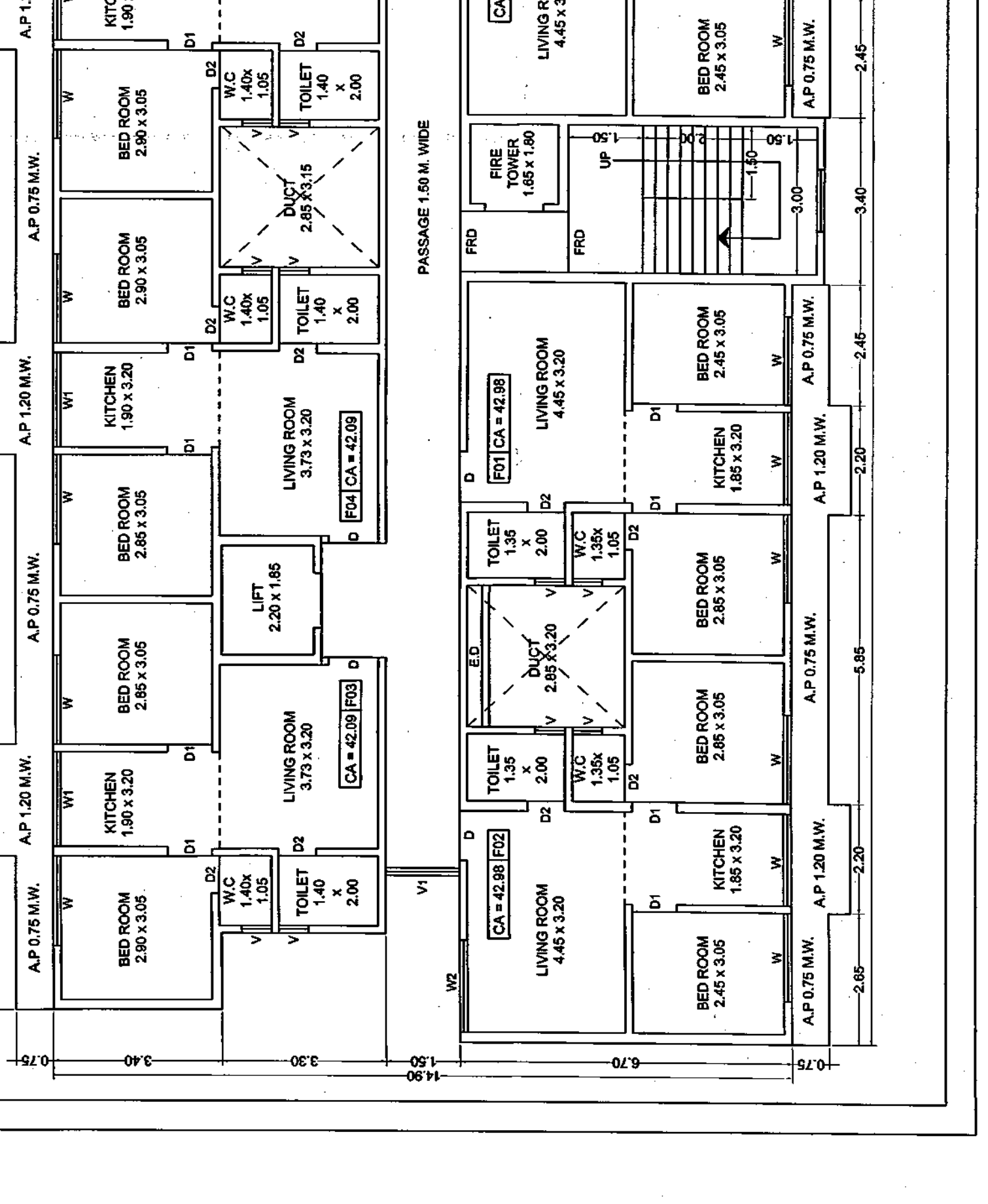
