











Route Map of the property site u/r







Note: The Blue line shows the route to site from nearest railway station (Nashik Road – 16.4 KM.)








- 3. A valuer shall endeavour to ensure that he/it provides true and adequate information and shall not misrepresent any facts or situations.

Professional Competence and Due Care
