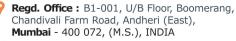





Note: The Blue line shows the route to site from Railway Station, Nashik (Nashik–7.4 Km.)







