



CONDITIONS UNDER AIR ACT:-

- 1. There shall be no use of fuel and there shall be no flue gas emission.
- 2. There shall be no process emission from the manufacturing process and other ancillary emission.
- 3. The industry shall take adequate measures for control of noise levels from its own sources within the premises so as to maintain ambient air quality standards in respect of noise to less than (a) 75 dB during day time and (b) 70 dB during nighttime. 7. Industry shall have to display on-line data outside the main factory gate with regard to quantity and nature of hazardous chemicals being handled in the plant, including wastewater and air emissions and solid hazardous waste generated within factory premises.

GENERAL CONDITIONS:

- 1. Adequate plantation shall be carried out all along the periphery of the industrial premises in such a way that the density of plantation is at least 1000 trees per acre of land and a green belt of 5.0 meters width is developed.
- 2. Applicant shall install low meters at inlet, recycle points and final outlet and maintain records for the same.

- 2. The above permission is subject to the conditions stipulated in the Annexure in addition to the following conditions: -
- (i) You shall export the entire production, excluding rejects and sales in the domestic tariff area as per provisions of EOU scheme for a period of 5 years from the date of commencement of production. For this purpose, the unit shall furnish the requisite Legal Undertaking as prescribed in the EOU scheme to the Development Commissioner, Kandla Special Economic Zone. Before signing the LUT it should have own operational Web-Site and permanent e-mail address. The unit would have the option to renew its EOU status or opt out of the scheme as per the Industrial Policy in force at that time in relation to items of production.
- (II) You shall achieve positive Net Foreign Exchange (NFE) as prescribed in the EOU scheme for a period of five years from the date of commencement of production failing which it would be liable for penal action.
- (iii) Import/local purchase of all Items except those listed in prohibited list of import/export will be permitted.
- (iv) This Letter of Permission is valid for 3 years from its date of issue within which you should implement the project and commence production and would automatically lapse if an application for the extension of validity is not made before the end of the said period. Date of commencement of production shall be intimated to the Development Commissioner, Kandla Special Economic Zone.

You shall provide details of investment to this office for verification duly certified by an Independent Chartered Accountant. Investment made should reflect in your Quarterly Performance Reports/ Annual Performance Reports also.

- (vi) The approval is based on the details furnished by you in your project application.
- (vii) You shall enter into a Legal Agreement in the prescribed form (Appendix-14-I-F) with Development Commissioner, Kandla Special Economic Zone, for fulfilling the terms and conditions mentioned in the Letter of Permission.
- (vili) You shall obtain statutory environmental/ pollution control clearances etc., as required.
- (ix) Exemption under Section 10-B of the Income Tax Act will be subject to Interpretation of the activity of the unit as manufacturing activity by the Income Tax Department.

ANNEXURE STANDARD CONDITIONS ATTACHED TO THE LETTER OF INTENT/PERMISSION IN RESPECT OF EXPORT ORIENTED UNITS

1. The production of the undertaking under this scheme shall be carried out in a Custom bonded area except where otherwise provided, location of the undertaking would be subject to the clearance by the concerned Commissioner of Customs. You are, therefore, advised to approach the jurisdictional Commissioner of Customs and Central Excise immediately in this behalf.

Import of capital goods, raw materials and components for production under the scheme shall be exempt from Customs duties in terms of Customs notification in force (subject to the conditions specified therein). Likewise, indigenously procured capital goods, components and raw materials required by the undertaking would also be exempt from the levy of excise duties in terms of relevant notification.

- 3. The finished products authorized for manufacture under the scheme shall be exempt from payment of excise duties on their export from India subject to the observance of the prescribed procedures. Export duties shall be leviable unless specifically exempted. The sale of goods manufactured in DTA would be permitted as per prescribed policy and Customs/Excise duties shall be levied as per-prescribed rates. The clearance of rejects, waste or scrap material rags, trimmings, etc. shall be governed by the provisions of policy as notified from time to time and clearance by Customs authorities in accordance with their notifications.
- On completion of the stipulated export obligation period covered by bond, Government may decide the conditions under which the undertaking may be allowed to produce for domestic tariff area and the conditions so decided shall be conditions attached to the concerned industrial licence of such undertakings.
- 5. On debonding after the period of export obligation, the undertaking will be liable to pay the following:

(a) Customs duty on capital goods on the depreciated value but at a rate prevalent

- on the date of clearance;

 (b) Customs during unused imported raw materials and components on value at the time of components in force on the date of clearance;
- xcis ble goods applicable excise duty on such goods and at rate (c) In respect d ed as on the date of clearance.
- 6. The undertaking will have to execute a Legal (Undertaking with the Development Commissioner, Kandia Special Economic Zone as prescribed in (Appendix 14-I-F) of the Handbook of Procedures (Vol.I).
- and the second second 7. Adequate steps shall be taken to the satisfaction of Government to prevent air, water and soil pollution. Such anti-pollution-measures to be installed should conform to the affluent and emission standards prescribed by the State Government in which the factory of the industrial undertaking is located. Further, adequate industrial safety measures as provided in the Factories Act shall be made to the satisfaction of the State Government in which the factory of the industrial undertaking is located.
- 8. In case of proposal for manufacture of Chemicals and Fertilizers and Pharmaceuticals, adequate steps shall be taken to the satisfaction of the Government in regard to process hazards for ensuring safety in plants. Before going into trial production, the adequacy of steps taken in this regard should be established to the satisfaction of appropriate Government authorities.
- 9. External Commercial borrowing, if any, shall be subject to the approval of Ministry of Finance (Department of Economic Affairs - ECB Division).
- 10. The applicant is required to send the quarterly progress report of implementation of the project in the prescribed proforma to the Development Commissioner, Kandla Special Economic Zone.
