4) Rs.8,60,000 (Rupees Eight Lakhs Sixty Thousands only) will be paid as part payment before registration of the Agreement for Sale.

5)Rs.1,40,000/- (Rupees One Lakh Forty Thousands Only) to be deducted from total sales consideration and paid towards @ 1% TDS under Income-Tax Act, 1961. The same 1% TDS will be

deposited by the TRANSFEREES with the Income-Tax authorities and the TDS certificate shall be handed over to the TRANSFERORS.

6)Balance payment of Rs.1,25,00,000/- (Rupees One Crore Twenty Five Lakhs Only)shall be paid within 45 days from the date of registration of the Agreement for Sale by obtaining loan from any financial Institution/Bank as FULL AND FINAL PAYMENT. In case the bank disbursal is lower, the TRANSFEREES shall adjust their own contribution accordingly.

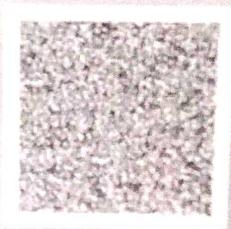
