- 2) The commencement / building permission shall remain valid for one year commencing from the date of its issue.
- 3) This permission does not entitle you to develop land which does not rest in you.
- 4) This commencement Certificate is renewable every year but such extended period shall not exceed three years provided further that such lease shall not be granted for fresh permission under section 44 of the Maharashtra Regional & Town Planning Act 1966.
- 5) This certificate is liable to be revoked by the Municipal Commissioner for Greater Mumbai if-
  - (i) The Development work in respect of which permission is granted under this certificate is not carried out or the use thereof is not in accordance with the said permission.
  - (ii) Any of the conditions subject to which the same is granted or any condition imposed by the Municipal Commissioner for Greater Mumbai is breached or violated.
- 6) The Municipal Commissioner for Greater Mumbai is satisfied that the name is obtained by the applicant through fraud or misrepresentation and the applicant and every person deriving title through or under him in such an event shall be deemed to have carried out the development work in consequence of Sections 43 or 45 of the Maharashtra Regional and Town Planning Act, 1966.
