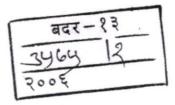

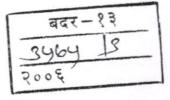

- a) By an Agreement dated 2nd day of September, 1974 as modified by an Agreement dated 6th December 1985 and executed between Navarrant B.
