Gentlemen,

Ref : Your letter dated 22-10-86.

By direction I have to inform you that the permission to occupy the completed portion of part third and 4th floor shown by you in the red colour in the plans submitted by you on 22-10-86 is hereby granted. Please note that this permission is without prejudice to action under section 353A/471 of B.M.C. Act and subject to the following conditions.

1. That the certificate u/s 270A of B.M.C. Act shall be obtained from A. E. W. W. P/S and a certified copy of the same shall be submitted to this office.
2. That all the terms and conditions of the approved layout/subdivision/amalgamation shall be complied with.
3. That the water supply for premises for which occupation is granted shall be restricted to 50% of normal requirements and no complaint for short supply shall be entertained in future.
4. That D.I.L.R.'s aft. for transfer of ownership of setback land in the name of M.C.G.B. shall be submitted before B.C.C.
5. Separate P.R. Cards for D.P. Roads, individual plots, internal layout Roads, 15% R.G. etc. along with C.T.S. plan should be submitted before B.C.C.
6. R.G. should be properly developed.
7. E.E.R.C.'s aft. for completion of road work in setback should be submitted within three months.
