With reference to above letter, this is to inform you that there is no objection to occupy Wing 'A' (Rehab) i.e. Ground + 1st to 6th floor except shop no.4 (Balwadi) & Society Office at ground floor which is constructed under supervision of Architect Shri Subodh Tari of M/s The Designers (Regn.
