

The Price for similar type of property in the nearby vicinity is in the range of ₹ 27,000.00 to ₹ 30,000.00 per Sq. Ft. on Built Up Area. Considering the rate with attached report, current market conditions, demand and supply position, Flat size, location, upswing in real estate prices, sustained demand for Residential flat, all round development of commercial and residential application in the locality etc. We estimate ₹ 27,155.00 per Sq. 





















Route Map of the property




