We have estimated the cost of Civil, MEP, and Allied works required for completion of the apartments and proportionate completion of internal & external works of the project as per specifications mentioned in agreement of Sale. Our estimated cost calculations are based on the Drawings/plans made available to us for the project under reference by the Developer / Consultants. The Schedule of items and quantity required for the entire work as calculated by Mr. Saeed appointed by Developer Engineer, and the assumption of the cost of material, Labour and other inputs made by developer, and the site inspection carried out by us to ascertain/ confirm the above analysis given to us.

We estimate total Estimated Cost of completion of the aforesaid project under reference as Rs. 36,15,00,000/- (Total of Table A and B) (Rs. 915,00,000 for wing A & B and Rs 27,00,00,000 for wing C).
