THIS AGREEMENT FOR SALE ("this Agreement") is made at Thane this 1st day of April 2024;

BETWEEN

NARANG REALTY PRIVATE LIMITED, a company incorporated under the provisions of Companies Act 1956 and deemed existing company under the provisions of Companies Act, 2013, having its registered office/principal place of business at Windsor, 1st floor, C.S.T. Road, Kalina, Santacruz (East), Mumbai – 400098, hereinafter referred to as the "**the Promoter**" (which expression shall unless it be repugnant to the context or meaning thereof, be deemed to mean and include its successors and permitted assigns) of the **ONE PART**

AND

MR. BHAVESH RAJENDRA SHIRODE (PAN DVXPS0860M) & MR. RAJENDRA DATTATRAYA SHIRODE (PAN ADPPS8029K) having their 922/23, Lodha Bhuvan, Malegaon, Nashik - 423203 hereinafter referred to as "**the Allottee**", (which expression shall unless it be repugnant to the context or meaning thereof be deemed to mean and include in case of an individual his/her/their heirs, executors, administrators and permitted assigns; and in case of a partnership firm, the partners or partner for the time being of the said firm, the survivor or survivors and the heirs, executors and administrators of the last survivor; and in case of a Hindu Undivided Family (HUF), the Karta and all the co-parceners/members of the HUF from time to time, , their respective heirs, legal representatives and the surviving co-parcener/member of the HUF and the heirs, executors, administrators and permitted assigns of such surviving co-parcener/member; in case of a Public Charitable Trust, all trustee/s from time to time constituting the said Trust, the surviving trustee and the heirs, executors and administrators of the surviving Trustee and his/her assigns and; in case of a Private Trust/Settlement, all trustees constituting the said Trust from time to time, beneficiaries and the heirs, executors and administrators of the surviving trustee or beneficiary and permitted assigns and; in case of a body corporate/company/Limited Liability Partnership, its successors and permitted assigns) of the **OTHER PART**

The Promoter and the Allottee/s are hereinafter collectively referred to as "**the Parties**" and individually as "**a Party**", as the context may so require.

WHEREAS:

- A. The Promoter is the owner of and is seized and possessed of and otherwise well and sufficiently entitled to undertake the development of all those pieces and parcels of land admeasuring 31,188 square meters (as per 7/12 Extracts) bearing Survey Nos.

146/5/B and 146/6/B/1 situated at Prahlad Keshav alias Acharya Atre Road, off Pokharan Road No. 1, Village Panchpakhadi, Taluka and District Thane and more particularly described in the **First Schedule** hereunder written and delineated by blue colour boundary line on the plan annexed and marked as **Annexure "1"** hereto, and hereinafter referred to as "**the Larger Land**". The details pertaining to the title of the Promoter to the Real Estate Project, the pertinent approvals and permissions to the Real Estate Project, litigations proceedings (if any), covenant affecting the Larger Land (if any), impediment (if any) in respect of the Larger Land, encroachment (if any) to the Larger Land, permission to be obtained which affects the Promoter's title to the Real Estate Project, and mortgages/charges on the Real Estate Project (if any) are set-out in the Legal Title Report dated 31st January, 2023 issued by M/s Wadia Ghandy & Co., Advocates and Solicitors, a copy whereof is annexed hereto and collectively marked as **Annexure "2"**.

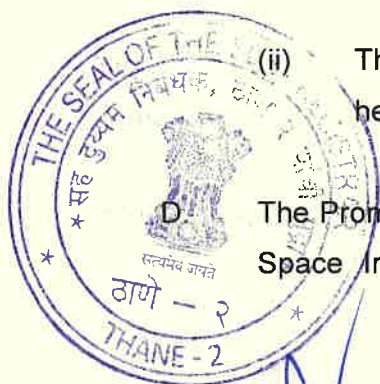
B. The statutory approvals mandatorily require the Promoter to handover certain stipulated percentage of the Larger Land to the concerned authorities or develop the same as public amenity. The Larger Land is affected by amenity (to be developed and handed over to TMC) and a portion of the Larger Land is also getting affected by road set back due to road widening of Acharya Atre Road. Out of the Larger Land, the Promoter has handed over (i) an area admeasuring 401.47 square meters to Thane Municipal Corporation ("TMC") towards road widening; and (ii) an area admeasuring 3228.97 square meters to TMC towards Amenity Open Space and presently. The Promoter may be required to hand over further portions of the Larger Land towards public amenity/road set-back or for any other purpose as may be required by the Thane Municipal Corporation. Presently, the area of the Larger Land remaining with the Promoter is 27,557.56 square meters. The area of the Larger Land remaining after the handover of the aforesaid portions of the Larger Land or the area which may be allowed by TMC for development shall constitute the area which shall be transferred to the Apex Society/Societies in the manner provided hereinbelow.

C. The details pertaining to the title/rights/entitlement of the Promoter to the Real Estate Project (defined hereinbelow) is as follows-

(i) There are no tenants/occupants on the Real Estate Project (defined hereinbelow) and the Promoter is in exclusive possession thereof;

(ii) There are no illegal encroachments on the Real Estate Project (defined hereinbelow);

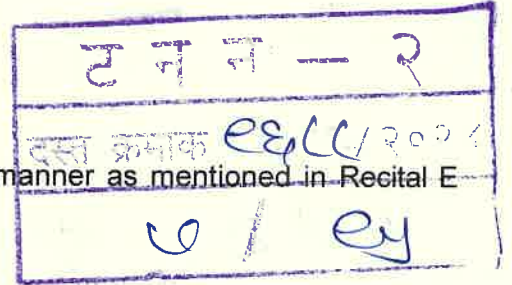
D. The Promoter is entitled to develop the Larger Land by consuming maximum Floor Space Index ("FSI") as more particularly set out in this Agreement and by

constructing buildings thereon in a phase-wise manner as mentioned in Recital E below in this Agreement ("the Whole Project").

E. The principal and material aspects of the development of the Whole Project as disclosed by the Promoter are briefly stated below-

- (i) The area of the Larger Land after deduction of amenity area and area falling/proposed to fall under road or for any other purpose as may be required by the Thane Municipal Corporation as per statutory authorities will be developed in a phase-wise manner.
- (ii) The Promoter proposes to utilize a total FSI of 2,50,000 Sq. Meter for the Whole Project on gross plot area of the Larger Land plus compensatory ancillary area FSI plus free of FSI areas aggregating up to approximately 2,50,000 square meters plus parking area/s and the amenities ("Full Development Potential") in the course of the phase wise development of the Whole Project.
- (iii) The Whole Project shall consist of the following other Buildings which shall be registered as individual real estate projects ("Other Buildings"):
 - a) Tower A (Tower No. 1) having Basements + 2 level podiums + Stilt + upto 50 upper floors;
 - b) Tower C (Tower No. 3) having Basements + 2 level podiums + Stilt + upto 50 upper floors;
 - c) Tower D (Tower No. 4) having Basements + 4 level podiums + Stilt + upto 50 upper floors;
 - d) Tower E (Tower No. 5) having Basements + 4 level podiums + Stilt + upto 50 upper floors;
 - e) Retail / Commercial Building having Basements + Ground + 10 upper floors.
- (iv) The Allottee has perused a copy of the Proposed Layout Plan ("Proposed Layout") and which is annexed to this Agreement as Annexure "3", which specifies the location of the Other Buildings to be built on the Larger Land together with a draft proforma specifying the proposed total FSI proposed to

be utilized on the Larger Land ("**Proposed Potential**"), and also, the tentative locations where common areas, facilities and amenities, reservations and other open and built-upon spaces are proposed to be situate. The Promoter is entitled to amend, modify and/or substitute the Proposed Layout of the Larger Land (defined below), in full or in part, as may be required by the applicable law or otherwise from time to time.

- (v) The nature of development of the Larger Land would constitute a mixture of users as may be permissible under applicable law from time to time and the Promoter shall be freely entitled to change or modify the area it proposes towards the aforesaid uses.
- (vi) The Promoter has disclosed to the Allottee/s the designated/proposed use of the various buildings / structures / towers / wings on the Larger Land specifying and identifying the Whole Project including *inter alia*, the Real Estate Project (defined below), and the phase/s in which the Promoter proposes to develop the Whole Project by utilizing the Full Development Potential ("**Proposed Layout**") and the proposed layout whereof is annexed to this Agreement as **Annexure "3"**. The Promoter shall be entitled to freely change the designated/proposed use of other buildings in the Larger Land.
- (vii) The materials that may be used by the Promoter in the Facilities / Amenities to be provided by the Promoter in the Real Estate Project are listed in the **Third Schedule** hereunder written and the same shall be completed/ delivered with the completion of the Real Estate Project.
- (viii) The Whole Project Amenities that may be usable by the Allottees are detailed in the **Fourth Schedule** hereunder written.
- (ix) As one of the Whole Project Amenities, the Promoter shall also construct a Club House known as 'Club House 1' consisting of Ground Floor + 2 upper floors at the location shown in the Proposed Layout ("**Common Club House**") in which the Allottee/s will be admitted as a member along with other allottee/s of the Other Buildings of the Whole Project. The Allottee/s and all other members of the Common Club House shall be governed by the rules of the Common Club House and the detailed terms and conditions in this regard shall be finalized and intimated by the Promoter.
- (x) The Promoter shall also construct a club house known as 'Club House 2' consisting of Ground Floor + First Floor by utilizing the FSI of 371.22 or such another FSI as may be amended from time to time ("**Promoter Club House**") and provide therein the amenities as may be decided and finalized by the

undertaken by the Promoter on lease, leave and license basis or such other method. For this purpose, the Promoter may lay and provide the necessary infrastructure such as cables, pipes, wires, meters, antennae, base sub-stations, towers etc.

- (xiii) The scheme and scale of development proposed to be carried out by the Promoter on the Larger Land will be in accordance with applicable law as amended from time to time.
- (xiv) The Promoter shall be entitled to put hoarding/boards of their Brand Name in a form of Neon Signs, MS Letters, Vinyl & Sun Boards on the Land and on the façade, terrace, compound wall or other part of the buildings/towers/wings as may be developed from time to time. The Promoter shall also be entitled to place, select, decide hoarding/board sites.
- (xv) The Promoter shall be entitled to confer title of particular building to such Societies, as mentioned at Clause 11.2 below.
- (xvi) The details of formation of the Apex Body, and, conferment of title upon the Apex Body with respect to the Larger Land and all common areas, facilities and amenities, basements, podiums and other spaces and areas on the Larger Land.

The above details and further aspects of the proposed future and further development of the Larger Land, are available for inspection on the website of the Authority at <https://maharera.mahaonline.gov.in>.

- F. The Promoter proposes to develop on a portion of the Larger Land a multi-storied building for residential use, being Tower No. 2 as a phase of the Whole Project in accordance with the plans approved/to be approved by the TMC (**"the said Building"**).
- G. 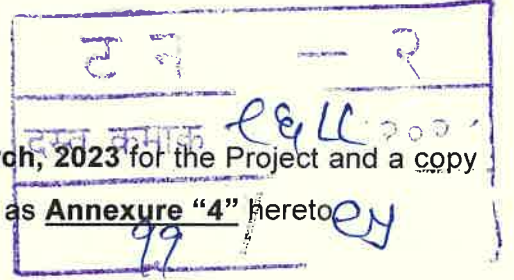

H. The principal and material aspects of the development of the Real Estate Project as being registered with the Authority, are briefly stated below-

- (i) The Real Estate Project is being constructed and developed on the said Land shown shaded with blue colour on the plan annexed and marked as **Annexure "1"** hereto.
- (ii) The said Real Estate Project has been presently sanctioned/approved by the TMC for Basements + Podium (Ground Floor) + Podium (First Floor) + Stilt + 35 upper floors.
- (iii) Total FSI of 25,950.87 sq. mts corresponding to 38 (thirty eight) upper floors has been currently proposed to be consumed / utilized in the construction and development of the Real Estate Project. 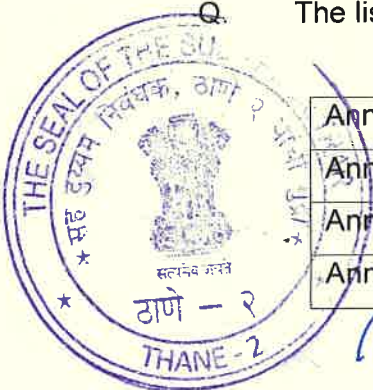

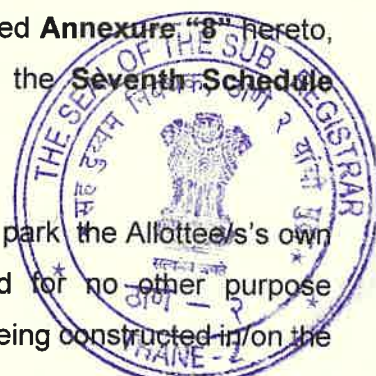

The exact location and identification of such car parking space/s will be finalized by the Promoter at the time of handing over possession of the said Premises and the same shall be duly accepted by the Allottee/s without raising any grievances.

- 3.3 The Sale Price for the said Premises (inclusive of the proportionate price of the Limited Areas and Facilities, if any) is mentioned in the **Seventh Schedule** hereunder written ("**the Sale Price**"). It is expressly agreed between the Parties that for the purpose of this Agreement, 20% (twenty percent) of the Sale Price is earnest money and is referred to herein as the "**Earnest Money**".
- 3.4 The Allottee/s has/have paid before execution of this Agreement, part payment of the Sale Price of the said Premises as more particularly described in the **Seventh Schedule** hereunder written and hereby agree(s) to pay to the Promoter the balance amount of the Sale Price in the manner and payment instalments more particularly mentioned in the **Eighth Schedule** hereunderwritten.
- 3.5 In addition to the Sale Price, the Allottee/s shall also bear and pay the taxes, consisting of tax paid or payable by way of Goods and Services Tax ("**GST**") (if applicable), and all levies, duties and cesses or any other indirect taxes which may be levied, in connection with the construction of and carrying out the Real Estate Project and/or with respect to the Premises and/or this Agreement. It is clarified that all such taxes, levies, duties, cesses (whether applicable/payable now or which may become applicable/payable in future) including GST (if applicable) and all other indirect and direct taxes, duties and impositions applicable levied by the Central Government and/or the State Government and/or any local, public or statutory authorities/bodies on any amount payable under this Agreement and/or on the transaction contemplated herein and/or in relation to the said Premises, shall be borne and paid by the Allottee/s alone and the Promoter shall not be liable to bear or pay the same or any part thereof.
- 3.6 The Sale Price is escalation-free, save and except escalations/increases, due to increase on account of development charges payable to the competent authority and/or any other increase in charges which may be levied or imposed by the competent authority / Local Bodies / Government from time to time. The Promoter undertakes and agrees that while raising a demand on the Allottee/s for increase in development charges, cost, or levies imposed by the competent authorities etc., the Promoter shall enclose the said notification / order / rule / regulation / demand, published/issued in that behalf to that effect along with the demand letter being issued to the Allottee/s, which shall only be applicable on subsequent payments.

Allottee/s prior to the possession of the said Premises in terms hereof, subject to a variation cap of 3% (three per cent). The total Sale Price payable on the basis of the carpet area of the said Premises, shall be recalculated upon confirmation by the Promoter. If there is any reduction in the carpet area beyond the defined limit of 3%, then, the Promoter shall refund the excess money paid by the Allottee/s within 45 (forty-five) days. If there is any increase in the carpet area allotted to the Allottee/s, the Promoter shall demand additional amount from the Allottee/s towards the Sale Price, which shall be payable by the Allottee/s prior to taking possession of the said Premises. Any payments by the Allottee(s) shall first be adjusted towards interest payable and any other due from the Allottee(s) and the balance, if any, shall be adjusted against the payment which is due against the Purchase Consideration. In case of delay in payment of any amounts as specified above, the Allottee(s) shall be liable to pay additional charges of Rs. 5000/- per installment towards administration charges. 3.11 The Promoter shall be entitled to securitise the Sale Price and other amounts payable by the Allottee/s under this Agreement (or any part thereof), in the manner permissible under RERA, in favour of any persons including banks/financial institutions and shall also be entitled to transfer and assign to any persons the right to directly receive the Sale Price and other amounts payable by the Allottee/s under this Agreement or any part thereof. 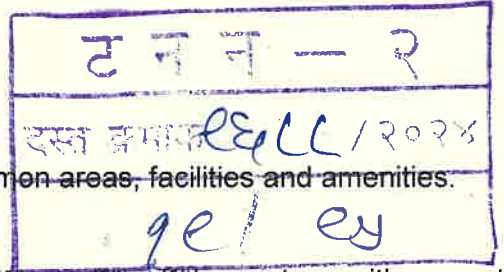

Whilst undertaking the development of the Whole Project and the Larger Land to its full and maximal potential as mentioned at Recital E above, there may be certain additions/modifications to the Whole Project Included Amenities and/or relocations/realignments/re-designations/changes, and the Allottee/s hereby consent(s) and agree(s) to the same.
- 4.2.7 The Allottee/s has/have carried out his/her/it's/their independent due diligence and search in respect of the development of the Real Estate Project and the Whole Project being undertaken by the Promoter and pursuant thereto, find no inconsistency in the development/construction of the Real Estate Project, the Whole Project and the Larger Land, and also in compliance of applicable laws including but not limited to the DCPR.

4.3 **Construction & Finishing:**

- 4.3.1 The Promoter had appointed/will appoint, third party contractor(s) for construction and execution of the Real Estate Project. In case of defect(s) in construction or workmanship, the Promoter and the Allottee/s shall collectively approach the third-party contractor(s) for the rectification of the defect(s).
- 4.3.2 In spite of all the necessary steps and precautions taken while designing and

constructing the Real Estate Project, the concrete slabs/beams may deflect due to self-weight, imposed load, creep and/or shrinkage phenomena (the inherent properties of concrete), for years after construction. Further, the Allottee/s may come across cracks in finishes, flooring, ceiling, slab gypsum etc. as a result of such slab/beam deflection and also caused due to any renovation and /or alterations etc. carried out by the Allottee/s and any other allottee/s/occupants of the other apartments/flats in the Real Estate Project. The Allottee/s agree(s) and covenant(s) not to hold the Promoter liable and/or responsible for any such defects arising out of inherent properties of concrete and/or caused due to any renovations and/or alterations etc. carried out by the Allottee/s and any other allottee/s/occupants of the Real Estate Project and the Allottee/s shall not raise any claim(s) against the Promoter in this regard.

4.3.3 All materials including marble, granite, timber etc., contain veins and grains with tonality differences and though the Promoter had pre-selected such natural materials for installation in the Real Estate Project, their non-conformity, natural discoloration or tonal differences at the time of installation is unavoidable and the Promoter shall not be responsible and/or liable for the same and the Allottee/s shall not raise any claim(s) against the Promoter in this regard.

4.4 **Rights and Entitlements of the Promoter & Nature of Development of the Larger Land:**

The Allottee/s agree(s), accept(s) and confirm(s) that the Promoter is entitled to the rights and entitlements in this Agreement including as stated in this Clause 4.4 in accordance with what is stated at Recitals D and E hereinabove:-

4.4.1 The Larger Land is being developed in a phase-wise manner by constructing and developing multiple buildings / towers / wings / structures thereon including the Real Estate Project, the Whole Project, the Accesses/Pathways/Roadways, in the manner more particularly detailed at Recitals D and E hereinabove. The Promoter shall be entitled to develop the Larger Land as the Promoter deems fit in accordance with the approvals and permissions as may be issued from time to time and this Agreement and the Allottee/s has/have agreed to purchase the said Premises based on the unfettered rights of the Promoter in this regard.

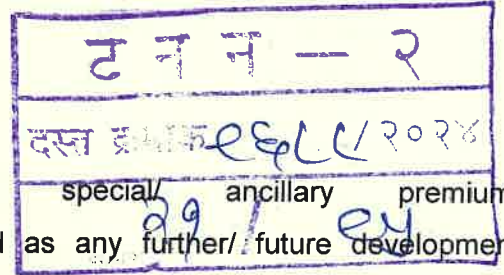

4.4.3.4 To apply for and obtain amended/ substituted/ revised/ modified layout plans, building plans and floor plans sanctioning construction of the Real Estate Project and the Whole Project upto such floors as may be permissible whilst exploiting the full and maximal development potential of the Whole Project and the Larger Land as stated in this Agreement;

4.4.3.5 Make amendments, modifications, variations, alterations, changes, deletions and revisions with respect to the development of the Whole Project;

4.4.3.6 To construct, develop and raise buildings, structures, towers and wings on the Larger Land, with and without common podium levels and other common levels;

4.4.3.7 To construct, develop and raise additional levels, floors and storeys in buildings, structures, towers and wings on the Whole Project and the Larger Land and the Allottee/s shall not have any claim(s) against the Promoter in this regard;

4.4.3.8 To construct lesser number of upper floors (from what is disclosed in the Proposed Layout in respect of the Real Estate Project and/or the Whole Project or any part thereof, and the Allottee/s shall not have any claim(s) against the Promoter in this regard;

4.4.3.9 Construct site offices/sales lounge on the Whole Project and the Larger Land (or part thereof) and to access the same at any time;

4.4.3.10 To (by itself or through its workmen, staff, employees, representatives and agents) enter into and upon the Whole Project and the Larger Land and any construction thereon including the Real Estate Project, and the Basements to Podiums Areas in the Whole Project, including to view and examine the condition and state thereof;

The Promoter has further informed the Allottee/s that all the expenses and charges of the aforesaid amenities and conveniences may be common and the Allottee/s along with other allottee/s of flats/units/premises in the Real Estate Project and/or in the Whole Project, and the Allottee/s shall share such expenses and charges in respect thereof as also maintenance charges proportionately. 4.4.3.18 The Promoter shall be entitled to construct in, over or around or above the terrace of the Real Estate Project any additional area or facility as may be permitted within the rules of the TMC and/or any other authority and shall be solely entitled to operate and manage the same.

4.4.4 The overall development of the Larger Land being dynamic in nature, may warrant changing or shifting the place/location on which amenities are provided, including the Whole Project. The Promoter shall complete the construction of common areas and facilities as well as the amenities over a period of time and in a phase wise manner.

4.4.5 The Promoter may appoint a single and/or multiple third party/agency for the purpose of operating and maintaining the Real Estate Project, the Basements to Podiums Levels, the Whole Project and/or the Larger Land or any part thereof including any common areas facilities and amenities and common areas on such terms and conditions as it may in its sole discretion deem fit.

4.4.6 Subsequent to the conveyance to the Society, and the Other Societies (defined below) as stated at Clause 11.2 below and the Apex Body Conveyance (defined below) as stated at Clause 11.4 below and completion of development of the Whole Project and the Larger Land, the Promoter will retain air rights (including the air rights above the Real Estate Project, the Basements to

Until the conveyance to the Society and the Other Societies as stated at Clause 11.2 below and the Apex Body Conveyance as stated at Clause 11.4 below, the Promoter shall be entitled to use and allow third parties to use any part of the Real Estate Project and/or the Larger Land respectively for installation of cables, satellite, communication equipment, cellular telephone equipment, radio turnkey equipment, wireless equipment and all other equipment etc. and the Promoter shall be entitled to receive, recover, retain and appropriate all the rents, profits and other compensation including any increase thereof which shall belong to the Promoter.

4.4.8 The Promoter shall be entitled to designate any spaces/areas on the Whole Project and the Larger Land, the Real Estate Project, the Basements to Podiums Areas in the Whole Project or any part thereof (including on the terrace and basement, lower ground, podium levels of the Real Estate Project) for third party service providers, for facilitating provision and maintenance of utility services (including power, water, drainage and radio and electronic communication) to be availed by the occupants of the units/premises to be constructed thereon. Such advertising and signage may comprise of hoardings, print media, electric signs, and may be constructed in a permanent or temporary manner and may be maintained, serviced, repaired and replaced and the Promoter and its nominees shall have access to such hoardings, print media and electric signage for this purpose.

4.4.10 The name of the Real Estate Project shall always be "Narang Privado - B" and shall not be changed without the prior permission of the Promoter.

4.4.11 In the event any flats/premises/spaces/areas in the Real Estate Project are unsold/unallotted/unassigned on execution and registration of the conveyance to Society as stated at Clause 11.2 below, the Promoter shall continue to be entitled to such unsold areas and to undertake marketing etc. in respect of such unsold areas as stated hereinabove. The Promoter shall be required to pay a sum of Rs.1000/- (Rupees One Thousand only) per month in respect of each unsold premises towards the outgoings, maintenance and other charges by whatever name called and shall not be liable or required to bear and/or pay any other amount by way of contribution, outgoings, deposits, transfer fees/charges and/or non-occupancy charges, donation, premium any amount, compensation whatsoever to the Society/Apex Body for the sale/allotment or transfer of the unsold areas in the Real Estate Project or elsewhere, save and except the municipal taxes at actuals (levied on the unsold premises).



4.4.12 The Promoter and their surveyors and agents and assigns with or without workmen and others, shall be permitted at reasonable times to enter into the said Premises or any part thereof for the purpose of making, laying down maintaining, repairing, rebuilding, cleaning, lighting and keeping in order and good condition (including repairing) all services, drains, pipes, cables, water

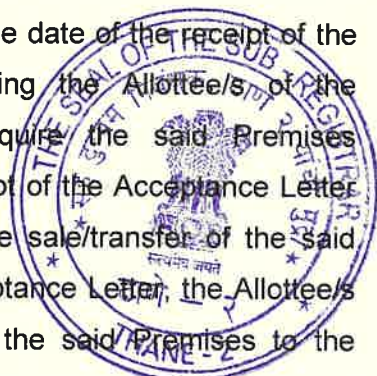

covers, gutters, wires, walls, structure or other conveniences belonging to or serving or used for the Real Estate Project. The Allottee/s is/are aware that the main water/drainage pipes of the Real Estate Project may pass through certain areas within the said Premises. 4.4.13.1 The Allottee/s shall address a letter ("**Offer Letter**") to the Promoter stating therein (i) the name and address of the proposed transferee (ii) the proposed sale price (such sale price shall be denominated in rupees i.e. INR) and hereinafter referred to as ("**Offer Price**"), including the proposed amount and consideration and terms and conditions offered by such proposed transferee, (iii) the date of consummation of the proposed sale, (iv) a representation that the proposed transferee has been informed of the terms this Agreement and in particular, the terms embodied into this clause. The Offer Letter shall include a calculation of the fair market value of the said Premises and an explanation of the basis for such calculation.

4.4.13.2 In the event the Promoter wishes to exercise the ROFR upon the said Premises, the Promoter shall, at its sole option, be entitled to purchase the said Premises under the Offer Letter at the Offer Price, in which case, the Promoter shall address a letter to the Allottee/s within a period of 7 (seven) days from the date of the receipt of the Offer Letter ("**Notice Period**") informing the Allottee/s of the Promoter's intention to purchase /acquire the said Premises ("**Acceptance Letter**"), and till the receipt of the Acceptance Letter the Allottee/s shall not proceed with the sale/transfer of the Said Premises. 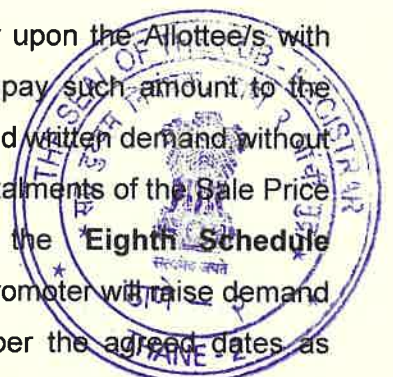
4.5 **Rights & Entitlements Of The Promoter Being Essence Of The Contract:**

The Allottee/s agree(s) that since the scheme of development of the Whole Project and the Larger Land placed before the Allottee/s as disclosed at Recital E above and in the Proposed Layout envisages the development of the Whole Project and the Larger Land in a phased manner to the Full Development Potential, the Allottee has/have, after understanding the nature of the scheme, agreed to the rights and entitlements of the Promoter as listed in this Agreement and this Clause 4 and in Recitals D and E hereinabove and the retention of these rights by the Promoter unto itself until completion of development of the Whole Project and the Larger Land as stated herein and as may be permissible under applicable law and these rights and entitlements shall be the essence of this Agreement. The Allottee/s agree(s), undertake(s) and confirm(s) that he/she/it/they will not obstruct, hinder or interfere with the development of the Whole Project and the Larger Land and all infrastructure thereon including common areas facilities and amenities as envisaged by the Promoter under the scheme of development.

5. **PAYMENTS**

5.1 With respect to any payments to be made by the Allottee/s to the Promoter in accordance with this Agreement, the Allottee/s agree(s), declare(s) and confirm(s) that:-

5.1.1 On a written demand being made by the Promoter upon the Allottee/s with respect to a payment amount, the Allottee/s shall pay such amount to the Promoter, within 7 (seven) days of the Promoter's said written demand without any delay, demur or default. It is clarified that the instalments of the Sale Price listed under schedule of payment stipulated in the **Eighth Schedule** hereunder are not listed in a serialized order. The Promoter will raise demand for payment of instalments of the Sale Price as per the agreed dates as mentioned in the **Eighth Schedule** or as and when the corresponding

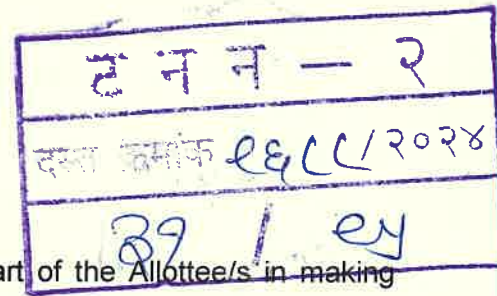
5.1.3 In case the Allottee/s enter(s) into any loan/financing arrangement with any bank/financial institution as envisaged at Clause 5.2 (*Loan & Mortgage*) below, such bank/financial institution shall be required to disburse/pay all such amounts due and payable to the Promoter under this Agreement, in the same manner detailed herein. If such bank/financial institution defaults in disbursing/paying the sanctioned amounts or part thereof and/or reduces the eligibility of the loan as sanctioned or part thereof as payable to the Promoter in the manner detailed in the **Eighth Schedule** hereunder written, then the Allottee/s agree(s) and undertake(s) to pay such amounts to the Promoter in the manner detailed in the **Eighth Schedule** hereunder written, otherwise, the same shall be construed as a default on the part of the Allottee/s and the Promoter shall be entitled to exercise the rights available in this Agreement. The Allottee/s further agree(s) and confirm(s) that in the event the Allottee/s enter(s) into any loan/financing arrangement with any bank/financial institution as envisaged at Clause 5.2 (*Loan & Mortgage*), the Allottee/s shall give his/her/their/its irrevocable consent to such bank/financial institution to make/release the payments, from the sanctioned loan, towards the Sale Price directly to the bank account of the Promoter, based on the payment schedule as described herein, upon receiving the demand letter/notice from the Promoter addressed to the Allottee/s and to the bank/financial institution, under intimation to the Allottee/s.

5.1.4 The timely payment of all the amounts payable by the Allottee/s under this Agreement (including the Sale Price), is the essence of the contract. An intimation forwarded by the Promoter to the Allottee/s that a particular milestone of construction has been achieved shall be sufficient proof thereof. The Promoter demonstrating despatch of such intimation to the address of the Allottee/s as stated at Clause 17 (*Notice*) including by e-mail, shall be conclusive proof of service of such intimation by the Promoter upon the Allottee/s, and non-receipt thereof by the Allottee/s shall not be a plea or an excuse for non-payment of any amount or amounts.

- 5.1.5 In the event of delay and/or default on the part of the Allottee/s in making payment of any GST, TDS or any other tax, levies, cess etc., then without prejudice to any other rights or remedies available to the Promoter under this Agreement or under applicable law, the Promoter shall be entitled to adjust against any subsequent amounts received from the Allottee/s, the said unpaid tax, levy, cess etc. along with interest, penalty etc. payable thereon from the due date till the date of adjustment.
- 5.1.6 The Promoter shall have a first and prior charge on the said Premises with respect to any amounts due and payable by the Allottee/s to the Promoter under this Agreement.
- 5.1.7 If the Allottee/s fail(s) to make any payments on the stipulated date/s and time/s as required under this Agreement, then, the Allottee/s shall pay to the Promoter interest at the Interest Rate (i.e. State Bank of India Highest Marginal Cost of Lending Rate plus 2% thereon) in terms of this Agreement, on all and any such delayed payments computed from the date such amounts are due and payable till the date such amounts are fully and finally paid together with the interest thereon at the Interest Rate in terms of this Agreement.
- 5.1.8 Without prejudice to the right of the Promoter to charge interest at the Interest Rate in terms of this Agreement, and any other rights and remedies available to the Promoter, either (a) on the Allottee/s committing default in payment on due date of any amount due and payable by the Allottee/s to the Promoter under this Agreement (including his/her/its proportionate share of taxes levied by concerned local authority and other outgoings) and/or (b) the Allottee/s committing 3 (three) defaults of payment of instalments of the Sale Price, the Promoter shall be entitled to at his own option and discretion, terminate this Agreement, without any reference or recourse to the Allottee/s. Provided that, the Promoter shall give notice of 15 (fifteen) days in writing to the Allottee/s ("**Default Notice**"), by Courier / E-mail / Registered Post A.D. at the address provided by the Allottee/s, of its intention to terminate this Agreement with detail(s) of the specific breach or breaches of terms and conditions in respect of which it is intended to terminate the Agreement. If the Allottee/s fail(s) to rectify the breach or breaches mentioned by the Promoter within the period of the Default Notice, including making full and final payment of any outstanding dues together with the Interest Rate thereon, then at the end of the Default Notice, the Promoter shall be entitled to terminate this Agreement by issuance of a written notice to the Allottee/s ("**Promoter Termination Notice**"), by Courier / E-mail / Registered Post A.D. at the address provided by the

Allottee/s. On the receipt of the Promoter Termination Notice by the Allottee/s, this Agreement shall stand terminated and cancelled. On the termination and cancellation of this Agreement in the manner as stated in this Clause and without prejudice to the other rights, remedies and contentions of the Promoter, the Promoter shall be entitled to forfeit the Earnest Money as and by way of agreed genuine pre-estimate of liquidated damages and not by way of penalty. 5.2.2 All the costs, expenses, fees, charges and taxes in connection with procuring and availing of the said loan, mortgage of the said Premises, servicing and repayment of the said loan, and any default with respect to the said loan and/or the mortgage of the said Premises, shall be solely and exclusively borne and incurred by the Allottee/s. The Promoter shall not incur any liability or obligation (monetary or otherwise) with respect to such loan or mortgage.

5.2.3 The agreements and contracts pertaining to such loan and mortgage shall not impose any liability or obligation upon the Promoter in any manner and shall be subject to and shall ratify the right and entitlement of the Promoter to receive the balance Sale Price and balance other amounts payable by the Allottee under this Agreement and in terms of Clause 3 herein, and shall also observe and be compliant with the terms of Clause 3 of this Agreement.

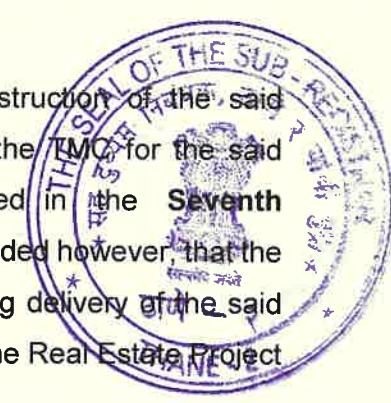
6. **CAR PARKING SPACE/S**

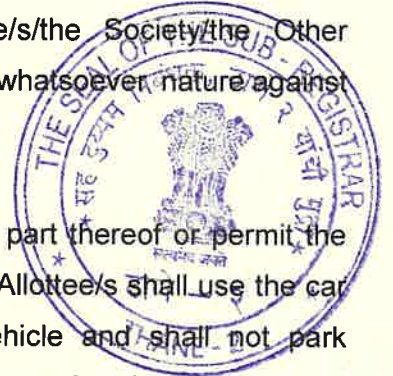

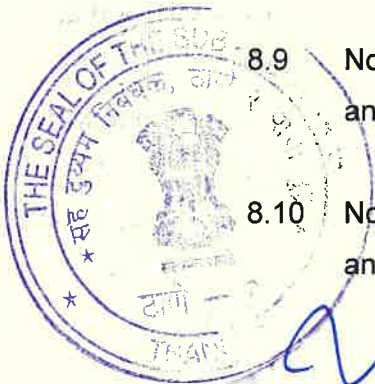

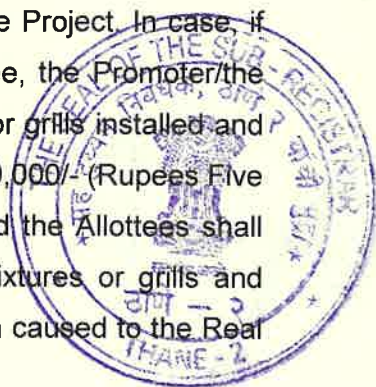

Larger Land and/or open spaces nor litter or permit any littering in the common areas in or around the said Premises and/or the Real Estate Project and/or the Larger Land and at the Allottee/s own cost and expense to make good and sufficient provision for the safe and efficient disposal of all waste generated at the said Premises and/or the Real Estate Project and/or open spaces to the requirement and satisfaction of the Promoter and/or relevant government and statutory authorities. If the Allottee/s or members of the Allottee/s family or any servant or guest of the Allottee/s commit(s) default of this sub-clause then the Allottee/s shall immediately take remedial action and shall also become liable to pay a sum of Rs.10,000/- (Rupees Ten Thousand Only) to the Promoter on each occasion on which the Allottee/s or any members of the Allottee/s family or any servant or guest of the Allottee/s commits default of this sub-clause. Upon conveyance to the Society and the Other Societies as stated at Clause 11.2, the Promoter shall hand over such amounts to the Society exclusive of any interest thereon and the same shall be reflected in the account/s of the Allottee/s with the Society and if the Allottee/s does/do not pay the aforesaid sum, the same shall be shown as amounts outstanding and due from the Allottee/s to the Society in the Society's account.

8.12.6 Not to do either by himself/herself/itself/themselves or through any other person anything which may or is likely to endanger or damage the Real Estate Project and/or the Larger Land or any part thereof, the garden, greenery, fencing, saplings, shrubs, trees and the installations for providing facilities in the Real Estate Project and/or the Larger Land. No damage shall be caused to the electricity poles, cables, wiring, telephone cables, sewage line, water line, compound gate, or any other facility provided in the Real Estate Project and/or the Larger Land. If the Allottee/s or members of the Allottee/s family or any servant or guest of the Allottee/s commits default of this sub-clause then the Allottee/s shall immediately take remedial action and shall also become liable to pay a sum of Rs.10,000/- (Rupees Ten Thousand Only) to the Promoter on each occasion on which the Allottee/s or any members of the Allottee/s family or any servant or guest of the Allottee/s commits default of this sub-clause. Upon conveyance to the Society and the Other Societies as stated at Clause 11.2, the Promoter shall hand over such amounts to the Society exclusive of any interest thereon and the same shall be reflected in the account/s of the Allottee/s with the Society and if the Allottee/s does/do not pay the aforesaid sum, the same shall be shown as amounts outstanding and due from the

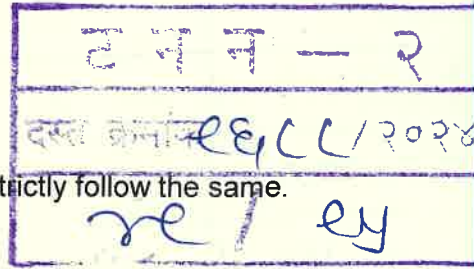

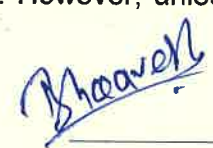
11. **FORMATION OF THE SOCIETY & APEX BODY**

11.1 **Formation of the Society and Other Societies:**

- (i) Upon 51% of the total number of units/premises in the Real Estate Project being booked by allottees, the Promoter shall submit an application to the competent authority to form a co-operative housing society to comprise of the Allottee/s and the other allottee/s of premises in the Real Estate Project, in accordance with and under the provisions of the Maharashtra Co-operative Societies Act, 1960 ("MCS Act") and the Rules made thereunder, read with the RERA Act and the RERA Rules.
- (ii) The Allottee shall, along with other allottees of premises/units in the Real Estate Project, join in forming and registering a co-operative housing society under the provisions of the Maharashtra Co-operative Societies Act, 1960 and the Rules thereunder and in accordance with the provisions of the RERA and RERA Rules, in respect of the Real Estate Project in which the allottees of the premises in the Real Estate Project alone shall be joined as members ("the Society").
- (iii) For this purpose, the Allottee/s shall co-operate with the Promoter and shall from time to time sign and execute the application for registration and/or membership and all other papers, forms, writings and documents necessary for the formation and registration of the Society and for becoming a member thereof including the bye-laws of the Society and shall duly fill in, sign and return to the Promoter within 7 (seven) days of the same being made available to the Allottee, so as to enable the Promoter to register the Society. No objection shall be taken by the Allottee if any changes or modifications are made in the draft/final byelaws of the Society, as may be required by the Registrar of Co-operative Societies or any other competent authority.
- (iv) The name of the Society shall be solely decided by the Promoter, and which shall not be changed by the allottee/s of premises in the Real Estate Project, without the prior written consent of the Promoter.
- (v) The Society shall admit all purchasers of flats and premises in the said Building as members, in accordance with its byelaws. However, unless and

until the Allottee/s is in full compliance of the terms and conditions of this Agreement including payment of the entire Sale Consideration, other charges and deposits and all other amounts/taxes payable hereunder/pursuant to this transaction to the Promoter /concerned authorities (as applicable), the Society shall not issue and deliver the share certificate to the Allottee.

(vi) The Promoter shall be entitled, but not obliged, to join as a member of the Society in respect of the unsold premises in the Real Estate Project. As and when the unsold premises in the Real Estate Project are sold by the Promoter, the Society shall admit the allottee/s of such premises as its members without being made subject to or liable to any separate, special, and/or additional condition and required to pay any amounts towards transfer fees, premiums, donations or by whatever name called, save and except the share application and entrance fees and in the manner as may be prescribed in the bye-laws of the Society and the Allottee/s shall not raise any objection thereto.

(vii) In the event any flats/premises/spaces/areas in the Real Estate Project are unsold/unallotted/unassigned on execution and registration of the conveyance to Society, the Promoter shall continue to be entitled to such unsold areas and to undertake marketing etc. in respect of such unsold areas as stated hereinabove. The Promoter shall not be required to take any NOC or consent from the Society in respect of the sale and marketing of the unsold premises in the Real Estate Project. The Promoter shall be required to pay a sum of Rs.1000/- (Rupees One Thousand only) per month in respect of each unsold premises towards the outgoings, maintenance and other charges by whatever name called and shall not be liable or required to bear and/or pay any other amount by way of contribution, outgoings, deposits, transfer fees/charges and/or non-occupancy charges, donation, premium any amount, compensation whatsoever to the Society/Apex Body for the sale/allotment or transfer of the unsold areas in the Real Estate Project or elsewhere, save and except the municipal taxes at actuals (levied on the unsold premises)

(viii) Post receipt of Occupation Certificate, the Society shall be responsible for the operation and management and/or supervision of the Real Estate Project, and the Allottee shall extend necessary co-operation and shall do the necessary acts, deeds, matters and things as may be required in this regard.

(ix) With respect to the allottees of premises/units in the Other Buildings developed on the Larger Land, the Promoter has formed/shall form separate

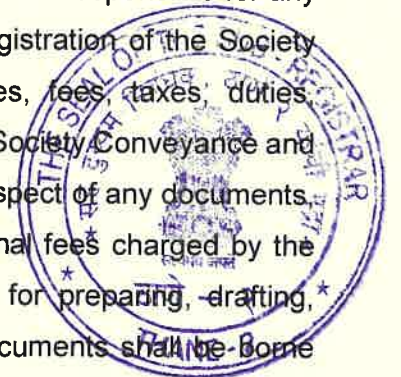

co-operative societies for each of the Other Buildings and/or each of the real estate projects registered in respect thereof under the provisions of the MCS Act 1960 and the Rules made thereunder, read with RERA and the RERA Rules ("Other Societies").

- (x) The cost, charges, expenses, levies, fees, taxes, duties, including stamp duty and registration charges, with respect to the formation of the Society shall be borne and paid by the Society and their respective members/intended members including the Allottee and the Promoter shall not be liable towards the same. However, the charges towards (a) drafting any documents, instruments, papers and writings, (b) professional fees charged by the Advocates & Solicitors engaged by the Promoter for preparing, drafting and approving all such documents, has been covered in Clause 18.

11.2 Conveyance to the Society and Other Societies:

- (i) Within 3 (three) months from (a) the receipt of the entire sale consideration, other charges/ deposits and all other amounts from all allottee/s of premises in the Real Estate Project and (b) the date of issuance of the Full Occupation Certificate with respect to the Real Estate Project, the Promoter shall (subject to its rights to dispose of the unsold premises, if any, in the Real Estate Project and receive the entire sale consideration/sale price and all other amounts/outstanding dues from the allottee/s), execute/cause to execute the conveyance of the structure of the Real Estate Project together with the Real Estate Project's exclusive common areas, amenities and facilities as described in **Fourth Schedule** herein, provided however that the basements, podiums and stilts, common areas and facilities and Promoter Club House shall be retained by the Promoter and shall not be conveyed to the Society ("**Society Conveyance**").
- (ii) The Society shall be required to join in execution and registration of the Other Societies Conveyance. The Promoter shall not be responsible for any delay by the Society in the timely execution and registration of the Society Conveyance. The cost, charges, expenses, levies, fees, taxes, duties, including stamp duty and registration charges on the Society Conveyance and the transaction contemplated thereby including in respect of any documents, instruments, papers and writings, and the professional fees charged by the Advocates & Solicitors engaged by the Promoter for preparing, drafting, approving, execution and registration of all such documents shall be borne and paid by the Society alone and the Promoter shall not be liable towards

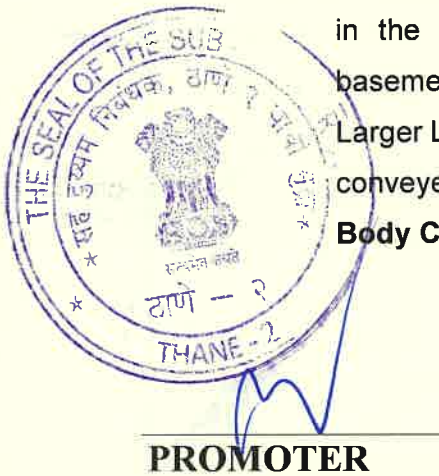

11.3.2 The cost, charges, expenses, levies, fees, taxes, duties, including stamp duty and registration charges, with respect to the formation of the Apex Body, including in respect of (a) any documents, instruments, papers and writings, (b) professional fees charged by the Advocates & Solicitors engaged by the Promoter for preparing, drafting and approving all such documents, shall be borne and paid by the Apex Body and its members/intended members, and the Promoter shall not be liable towards the same.

11.4 Conveyance of the Larger Land to the Apex Body:

- (i) Within a period of 3 (three) months of registration of the Apex Body, the Promoter and Apex Body shall execute and register an Indenture of Conveyance whereby the Promoter shall convey all its right, title and interest in the land comprised in the Larger Land and in all areas, spaces, basements, podiums, stilts, common areas, facilities and amenities in the Larger Land (save and except the Promoter Club House) that are not already conveyed to the Society/Other Societies, in favour of the Apex Body ("Apex Body Conveyance").
