 provided further that such lapse shall not bar the subsequent  
 application for fresh permission under section 45 of the  
 Maharashtra Regional & Town Planning Act, 1966.
6. This certificate is liable to be revoked by the Municipal  
 Commissioner for Greater Bombay if :  
 (a) The Development work in respect of which permission is  
 granted under this certificate is not carried out or the  
 use thereof is not in accordance with the sanctioned  
 plans.
