With reference to your application No. 7746 dated 2-2-1975 for Development Permission and Grant of Construction Certificate under Section 44 & 61 of the Maharashtra Regional and Town Planning Act, 1966, for new development and building permission under Section 246 of the Mumbai Municipal Corporation Act, 1948 in respect of building

at the development work of Proposed Area No. CIN No. 1234567890 (J-1961) at premises situated ... Besant Road, village ... No. 15, ... Ward No. 12

The Construction Certificate/Building Permit is granted under following conditions:

1. The said work in consequence of the extension of the above mentioned building line shall form part of the public street.

2. That no new building or part thereof shall be occupied or allowed to be occupied by any person until occupancy permission has been granted.

3. The Construction/Certified Development permission shall remain valid for the duration from the date of its issue.

4. This permission does not entitle you to develop land which does not vest in you.

5. This Construction/Certified Development permission is renewable every year but such extended period shall be limited to three years provided further that such leasehold shall not be any subsequent up to the date of such permission under section 44 of the Maharashtra Regional & Town Planning Act, 1966.

6. This Certificate is liable to be recalled by the Municipal Commissioner for Greater Mumbai if:-

(a) The Development work in respect of which permission is granted under this certificate is not carried out in the use thereof and in accordance with the measured plans.

(b) Any of the conditions subject to which the same is granted or any of the restrictions imposed by the Municipal Commissioner for Greater Mumbai is breached or not complied with.

(c) The Municipal Commissioner for Greater Mumbai is satisfied that the same is obtained by the applicant through fraud or corruption and the applicant and every person deriving title through or under him shall be liable to have arrested and the development work is in contravention of Section 42 or 43 of the Maharashtra Regional and Town Planning Act, 1966.

7. The conditions of this certificate shall be binding not only on the applicant but on his heirs, successors and assigns, administrators and successors and copy or memorandum title through or under him.
