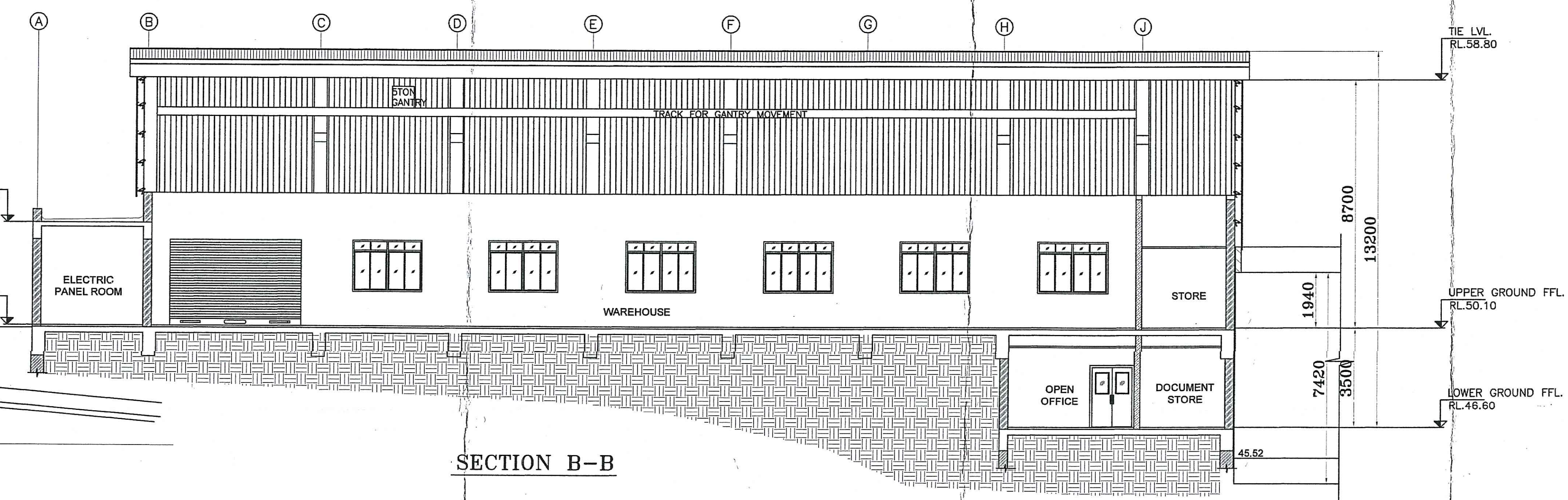
**LOWER GROUND FLOOR PLAN**
