## Method of Valuation / Approach

The sales comparison approach uses the market data of sale prices to estimate the value of a real estate property. 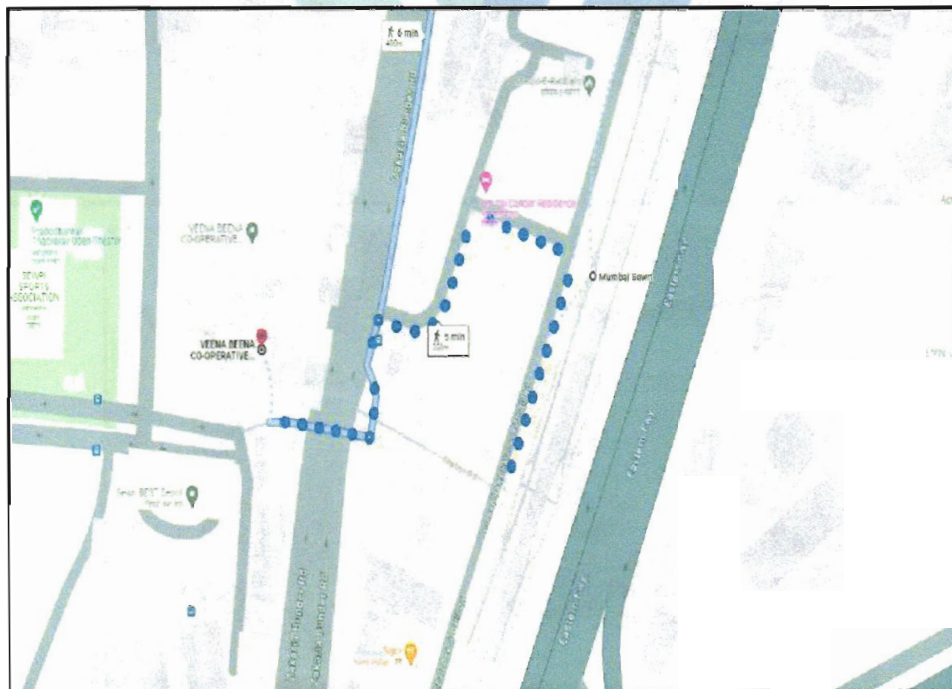
