



The Executive Engineer (Development Plan) (L.S.) of the Municipal Corporation of Greater Mumbai vide his letter bearing reference No. CHE/1 to R/34/DPES dated 23rd June, 1997 informed the Promoters that residential user has been allowed in respect of the said property subject to certain terms and conditions more particularly setout therein;
- I. An exemption order was passed by the Additional Collector and C. A.
