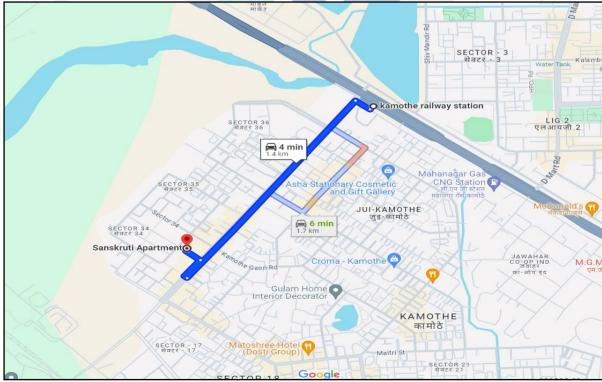






Route Map of the property

Note: The Blue line shows the route to site from nearest railway station (Kamothe – 1.4 km.)



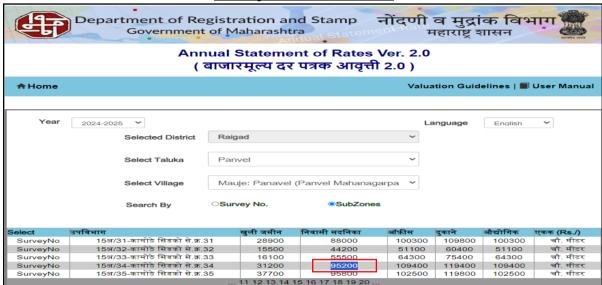

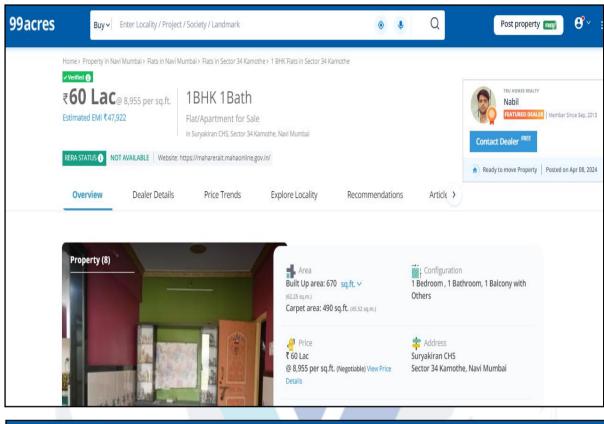

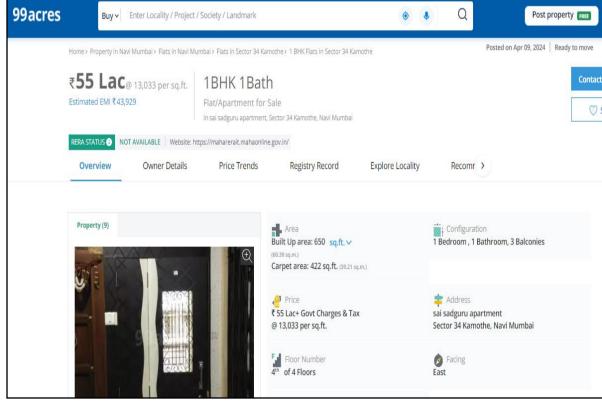
