With reference to your application No. P-17533/2023/(325 C)/K/E Ward/GUNDAVALI/CC/1/New Dated. 19 Jun 2023 for Development Permission and grant of Commencement Certificate under Section 44 & 69 of the Maharashtra Regional and Town Planning Act, 1966, to carry out development and building permission under Section 346 no 337 (New) dated 19 Jun 2023 of the Mumbai Municipal Corporation Act 1888 to erect a building in Building development work of on plot No. 325 C C.T.S. No. 325 C Division / Village / Town Planning Scheme No. GUNDAVALI situated at Situated at junction of Jiva Mahale Road and N S Phadke Marg Road / Street in K/E Ward Ward.

The Commencement Certificate / Building Permit is granted on the following conditions:--

- 1. The land vacated on consequence of the endorsement of the setback line/ road widening line shall form part of the public street.
- 2. That no new building or part thereof shall be occupied or allowed to be occupied or used or permitted to be used by any person until occupancy permission has been granted.
- 3. The Commencement Certificate/Development permission shall remain valid for one year commencing from the date of its issue.
- 4. This permission does not entitle you to develop land which does not vest in you.
- 5. This Commencement Certificate is renewable every year but such extended period shall be in no case exceed three years provided further that such lapse shall not bar any subsequent application for fresh permission under section 44 of the Maharashtra Regional and Town Planning Act, 1966.
- 6. This Certificate is liable to be revoked by the Municipal Commissioner for Greater Mumbai if :
  - a. The Development work in respect of which permission is granted under this certificate is not carried out or the use thereof is not in accordance with the sanctioned plans.
  - b. Any of the conditions subject to which the same is granted or any of the restrictions imposed by the Municipal Commissioner for Greater Mumbai is contravened or not complied with.
  - c. The Municipal Commissioner of Greater Mumbai is satisfied that the same is obtained by the applicant through fraud or misrepresentation and the applicant and every person deriving title through or under him in such an event shall be deemed to have carried out the development work in contravention of Section 43 or 45 of the Maharashtra Regional and Town Planning Act, 1966.
- 7. The conditions of this certificate shall be binding not only on the applicant but on his heirs, executors, assignees, administrators and successors and every person deriving title through or under him.

The Municipal Commissioner has appointed Shri. Executive Engineer (BP) K/East Ward Executive

Engineer to exercise his powers and functions of the Planning Authority under Section 45 of the said Act.

That Utmost care with all precautionary like sheet piling, excavation in steps/slope with proper gradient etc. shall be taken to safeguard the soil below the foundation of neighboring building, structure, roads and preventive and safety measures shall be adopted while carrying out the work to avoid the mishaps and accident.

3. Balance PAAA shall be submitted before issue of further CC.

4. This C.C. is without prejudice to legal matters pending in court of law if any.

5. That guidelines as per circular CHE/DP/214/Gen dated 15/09/2023 and MGC/F/1102/dated 25/10/2023 regarding measures to be taken to control the environmental pollution due to building construction activities shall be strictly complied with.
