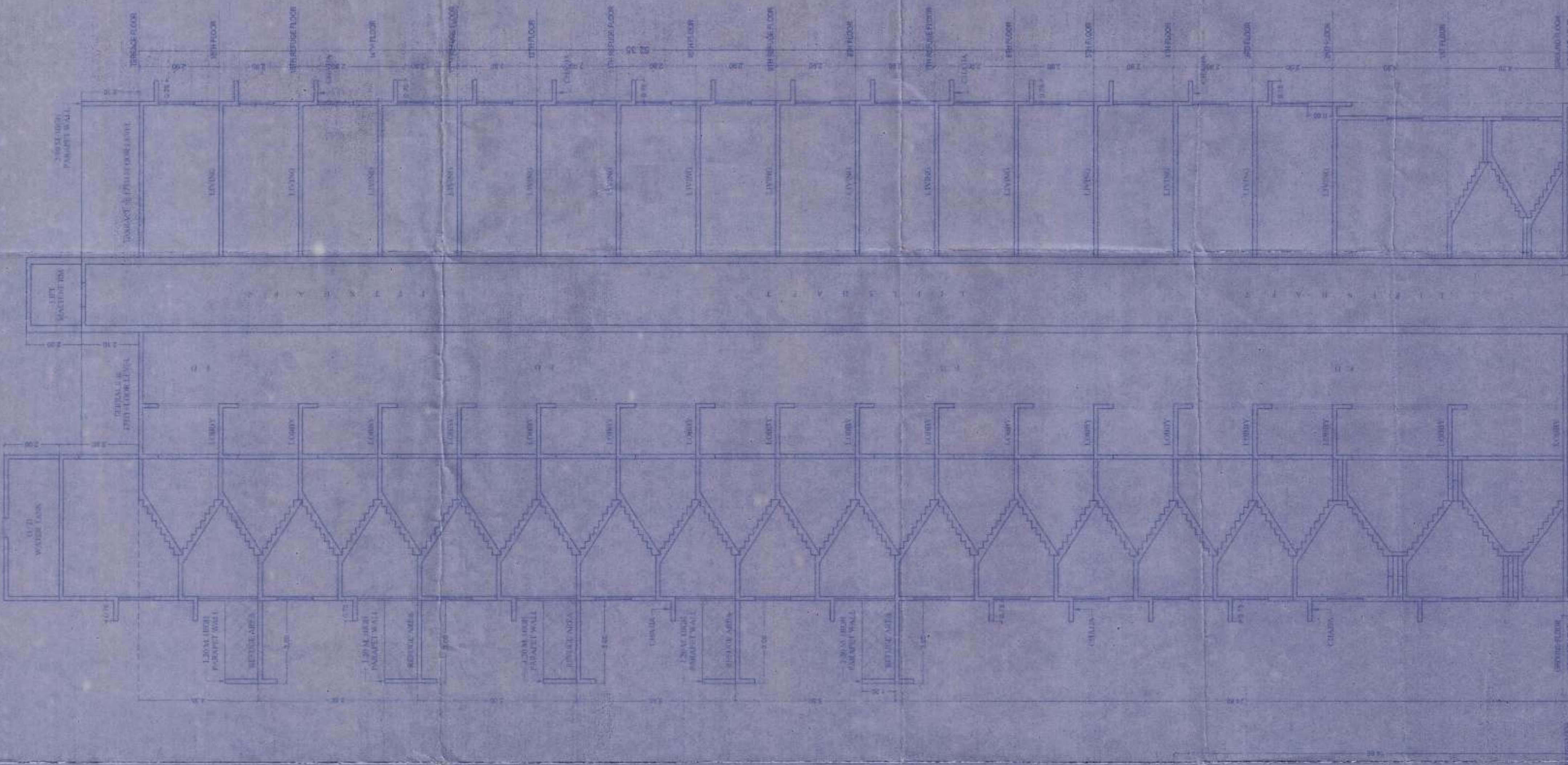

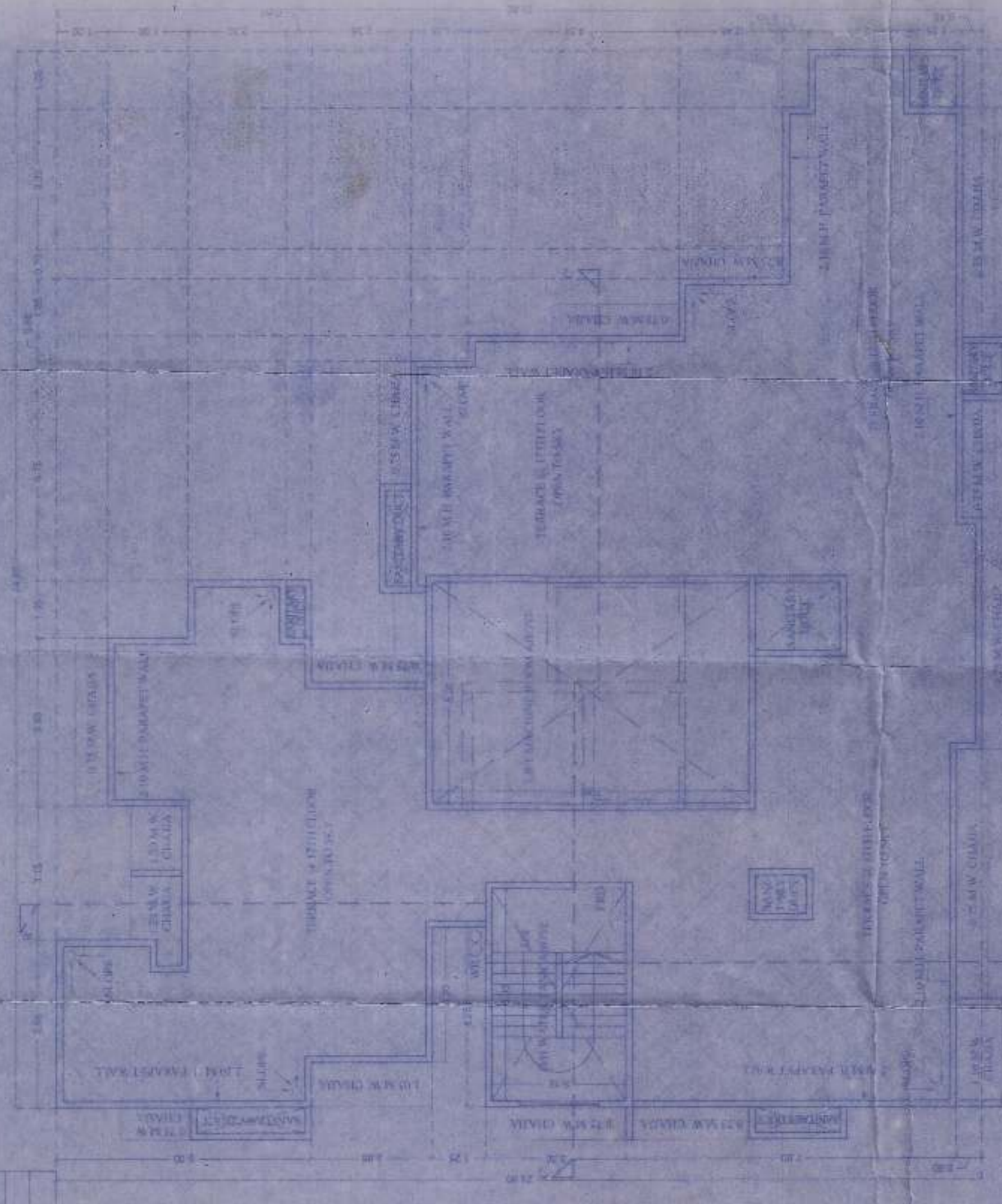
PARKING TOWER SECTION D-D FOR SALE BUILDING



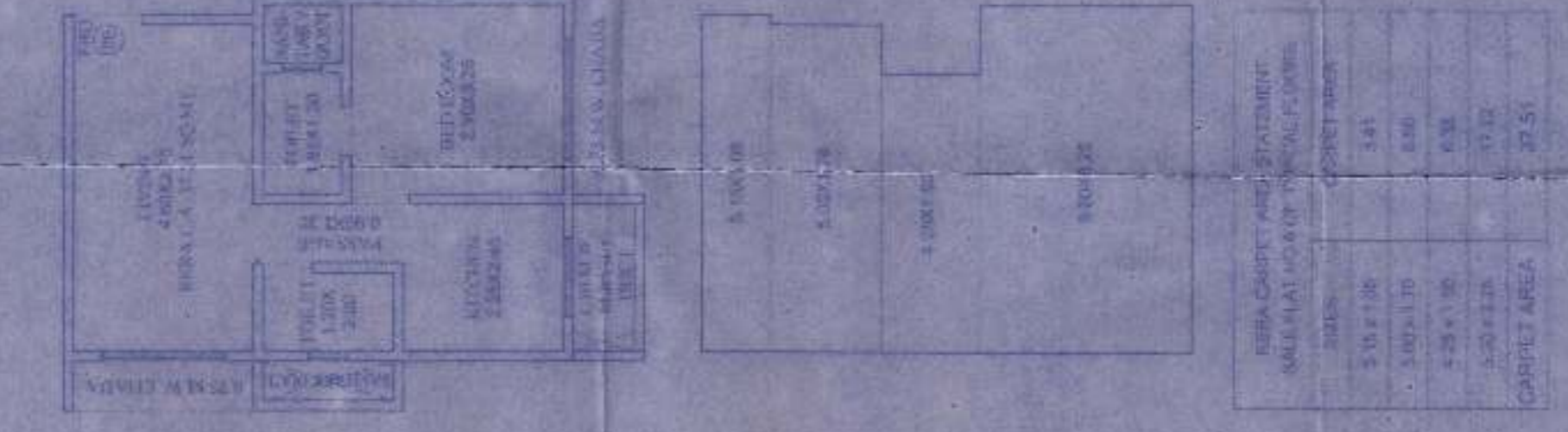
