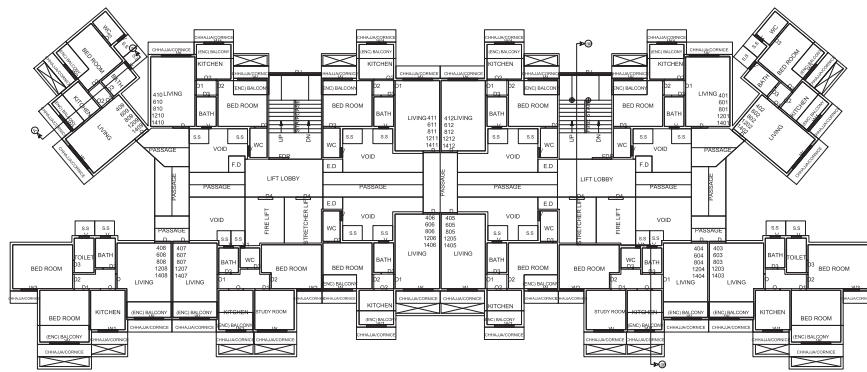

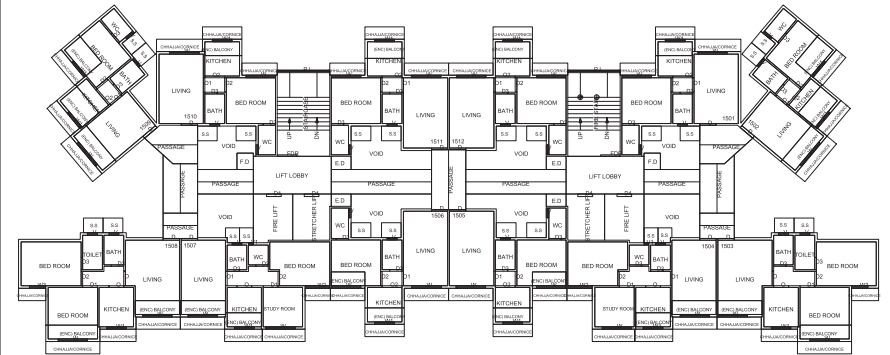


2ND, 7TH, 15TH FLOOR PLAN



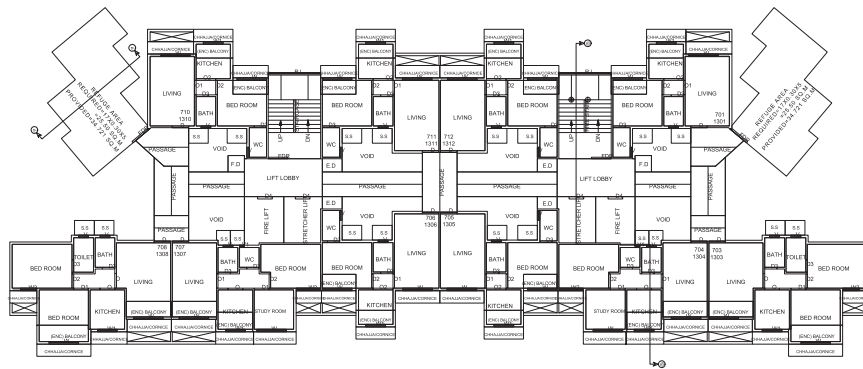
