LEAVE AND LICENSE AGREEMENT

THIS AGREEMENT is made and entered into at Sarigam on this 13 day of April 2022 Between –

M/s. <u>Techno Tarp and Polymers Private Limited (100% EOU), (PAN No. AACCT3607R)</u>, Occupation- Manufacturer, Residing at Plot No. 4913, 4914, 4915, 4920, 4921, Plastic Zone, G.I.D.C., Sarigam, Dist. Valsad, Gujarat-396 155. Hereinafter referred to as the "LICENSOR"

AND

M/s. <u>Techno Kitchenware Private Limited</u>, (PAN No. AAFCT4342L), Occupation-Manufacturer, Residing at Plot No. 4922, Plastic Zone, G.I.D.C., Sarigam, Dist. Valsad, Gujarat-396 155. Hereinafter referred to as the "LICENSEE"

AND WHEREAS the Licensor is absolutely seized and possessed of or otherwise well and sufficiently entitled to Industrial Plot/Shed No. 4922 (Area 1505 Sq. Mtrs.). hereinafter referred as "THE SAID PROPERTY"

AND WHEREAS the Licensee approached the Licensor for permission of using the said property of the Licensor's more particularly described in the schedule hereunder written for its use on leave and license basis.

AND WHEREAS the Licensor agreed to grant the Licensee and the Licensee have agreed to accept the said shed more described in the schedule followed hereunder:

THIS AGREEMENT WILL BE AS UNDER

- 1. The Licensor hereby grant on leave and license basis to the licensee to use THE SAID PROPERTY hereinafter referred to as the LICENSED PREMISES more particularly described in the schedule hereunder written for the period of 60 months commencing from 13.04.2022 to 12.04.2027. The Agreement can be extended for further period as decided by both the parties as per terms and condition decided by them.
- 2. The Licensee has to pay Rent Rs. 1, 00,000/- Per month (Rupees One Lakh Only) Rental shall be paid to the Licensor within 10th day of every month. All the Water charges, Drainage Charges and electricity charges are to be borne by the Licensee.
- 3. The Licensee has paid a sum of Rs. 1, 00,000/- (Rupees One Lakh Only) as a Security Deposit paid by Techno Kitchenware Private Limited. This shall be refunded peacefully without any Interest to the Licensee after the completion of the agreement and handing over of said property to the Licensor.
- The Licensee shall keep the shed in good condition while using Normal wear and tear is acceptable.
- Licensee will not make any major alteration or structural changes in the said property without prior permission from the Lessor.
- The Licensor will be fully responsible for the payment of any demand made by any financial institution for loan if taken or likely to be availed during the lease period.



7. The Licensee shall take any bank loan or GSFC loan or any other loan from financial institution in respect of shed with prior permission or consent from Licensor.

8. The Licensee shall not be entitled to sublet or underlet the above said property or any part thereof in favor of any person or persons.

9. The premises shall not be used for immoral or illegal purpose. No explosive materials (except Gas Connection or cylinder) should be kept/stored in the said property.

10. The Licensee shall not throw dirt, rubbish, rags or other refuse or permit the same to be thrown from his said property in the compound or any cortion of the said property.

During the entire term of the agreement the material kept in the premises will be the property of the Licensee and Licensor cannot claim or withhold material.

- 12. There will be a lock in period of 6 months after lock in period is over the Licensee can give the Licensor and Licensee shall be entitled to terminate this agreement by giving One month's prior written notice to the party during the continuance of this agreement.
- 13. After the agreement term is over, the first right of refusal will be with the Licensee.
- 14. In case of force Majeure or the business has to be closed down due to unforeseen circumstances than the Licensor give 30 days' notice to the Licensor for termination of the agreement during the entire term.
- 15. Any Liabilities of Government authorities of GPCB, Sales Tax, Income Tax, Goods and Service Tax and Excise & Customs pertaining to the business in the premises will be borne by Licensee.
- 16. Property taxes, municipality taxes if any for the Notified Area will be born by the Licensor.






