

THIS AGREEMENT made at Bombay this 19th day of November 1987, Between MR. P. H. SHAH, Indian Inhabitant, hereinafter called 'Vendor' (which expression shall, unless repugnant to the context or meaning thereof, be deemed to include his respective heirs, executors and administrators) of the One Part and MR. KASHYAP L. SHAH & MRS. SMITA K. SHAH, Indian Inhabitants, hereinafter called the 'Purchasers' (which expression shall, unless repugnant to the context or meaning thereof, be deemed to include their heirs, executors, administrators and assigns) of the Other Part.

WHEREAS:

The Vendor is holding a closed Garage No. 4 on Ground Floor, Building known as Mangal Milan Co-operative Housing Society Limited, registered under the provisions of the Maharashtra Co-operative Societies Act, 1960 and having its registered No: BOM/HSG/6650 of 1981 and having its registered office at Sharadchandra Chatterji Rd, Santacruz (West), Bombay 400 054, (hereinafter for brevity's sake called 'the said Society').

- 6. The Purchasers agree to observe and perform all the rules and regulations and bye-laws of the said Society as also of the Bombay Municipal Corporation and other authorities concerned in regard to the use of the said closed Garage and to keep the Vendor saved and indemnified against any claim, demand, action or proceedings and all costs, charges and expenses in respect of the same.
