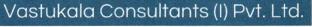

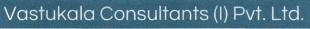

Note: The Blue line shows the route to site from nearest railway station (Ghatkopar – 4.0 Km.)

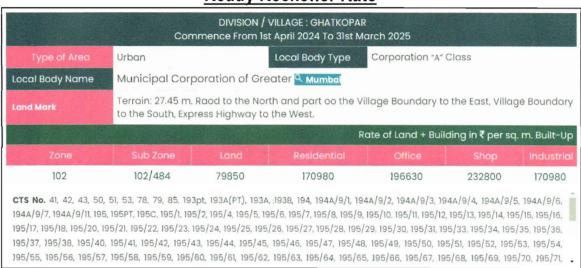
