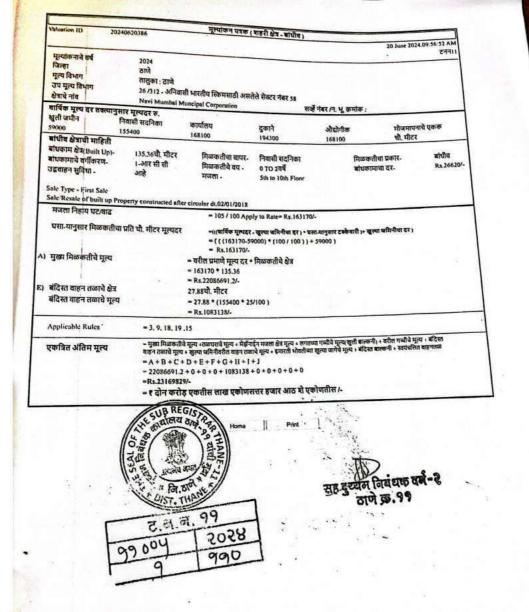
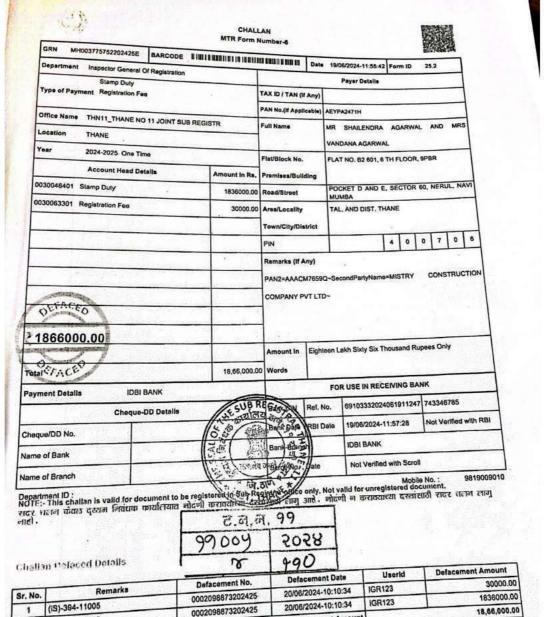

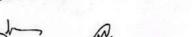

The Corporation under Section 118 of the MR&TP Act has the power and authority to dispose the lands acquired under Section 113A by lease;
- (II) The State Government of Maharashtra in accordance with its right to acquire lands, acquired the lands bearing Survey no. 264 belonging to one Agar Koiji and Survey no. 265 belonging to the Salt Department of State Government of Maharashtra of





Village Karave, Taluka Thane, District Thane (hereinafter collectively referred to as "Survey Nos. 264 & 265"), as per the Notification no. L.A.Q.C. 336 dated 3rd February 1970, Issued by Hon'ble Commissioner of Mumbal Division.

- (iii) Subsequently, the Corporation acquired the lands bearing Survey Nos. 264 & 265, as per the Notification no. L.A.Q. Karya1/K-1 CR 855 dated 19th October 1994 Issued by Hon'ble Commissioner of Mumbal Division, and vide Possession Letter dated 27th April, 1995, received possession of the lands bearing Survey Nos. 264 & 265 by Circle Officer, Special Acquisition Officer, Metro Centre No. 1, Thane.
