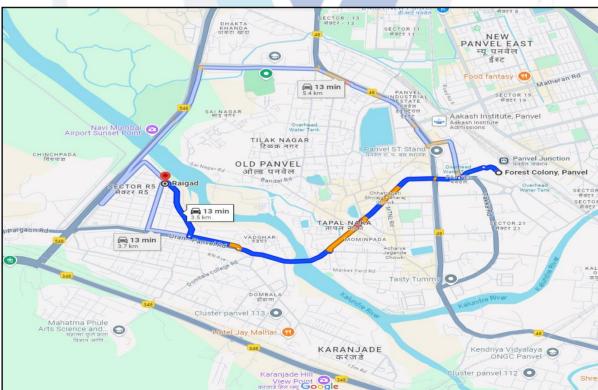






Route Map of the property Site,u/r

Note: The Blue line shows the route to site from nearest railway station (Panvel Junction – 3.5 km.)

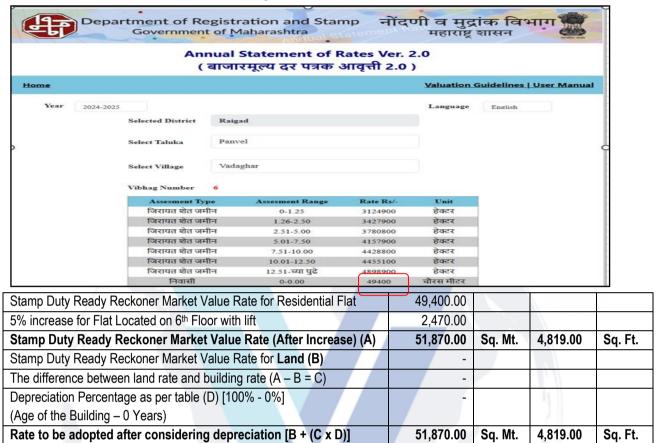

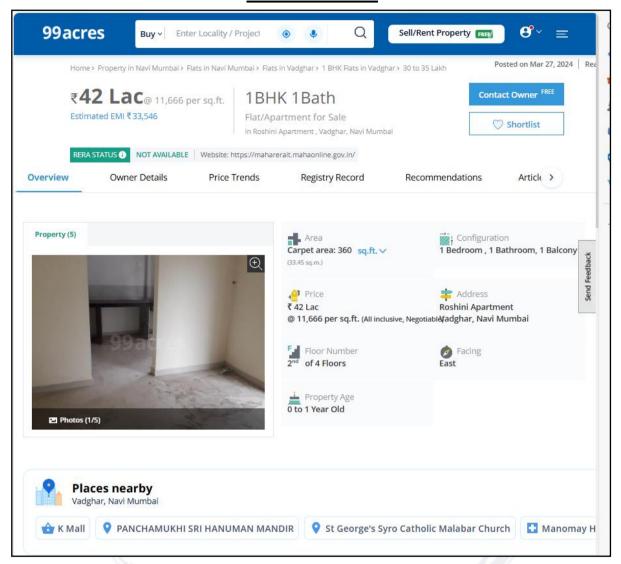

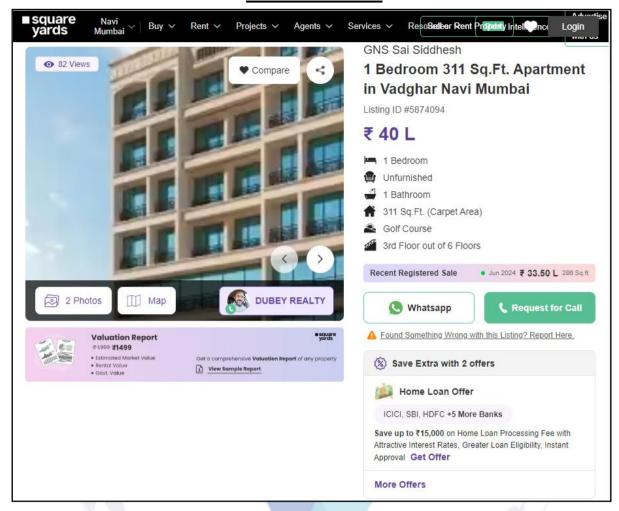
