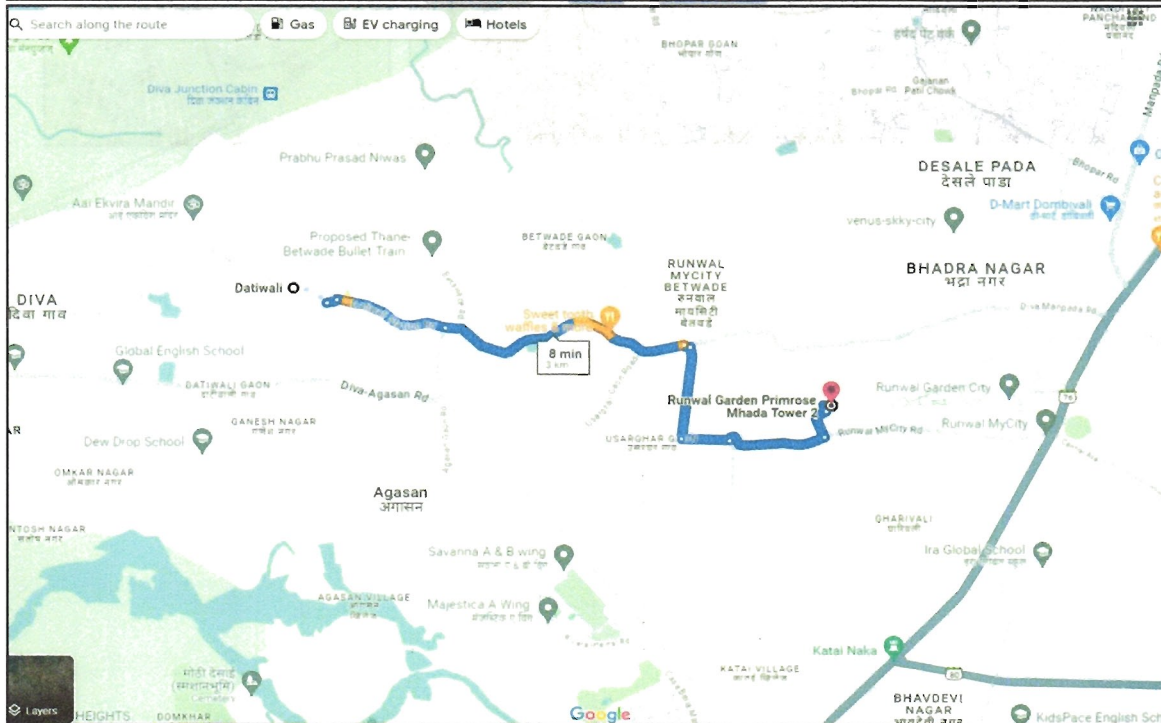
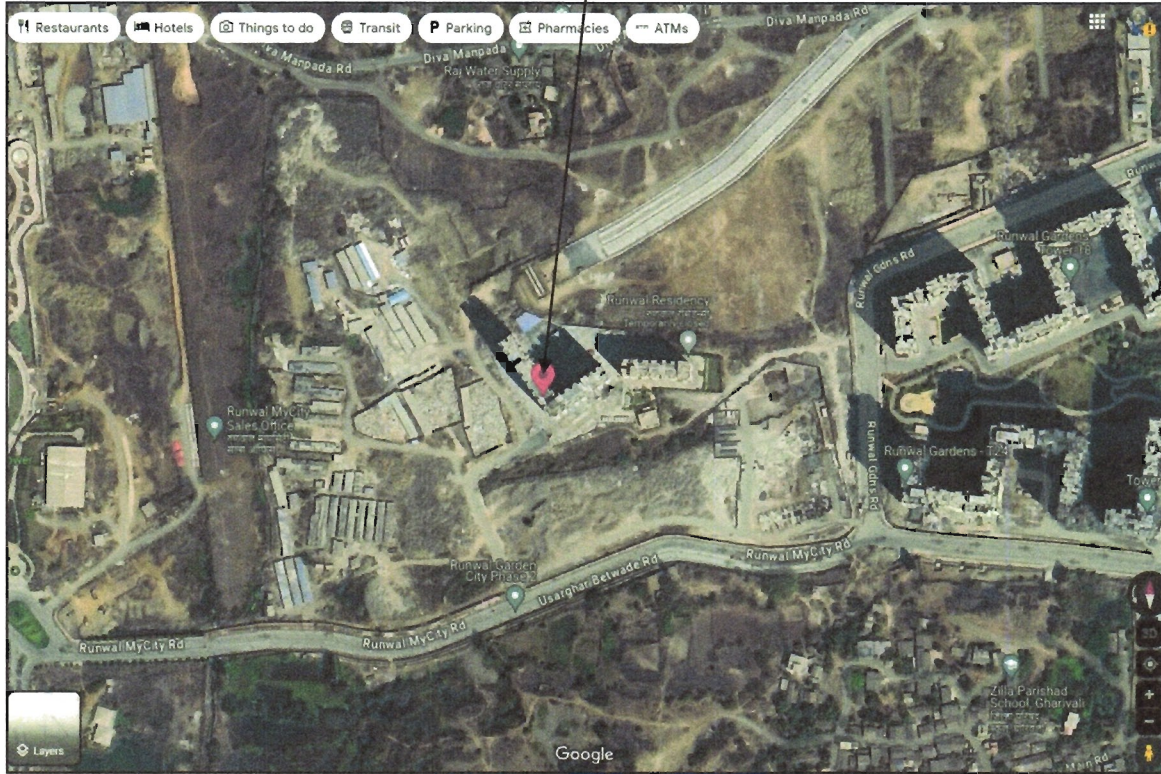

Note: The Blue line shows the route to site from nearest railway station (Datiwali – 3.00 Km.)





Justification for price / rate
