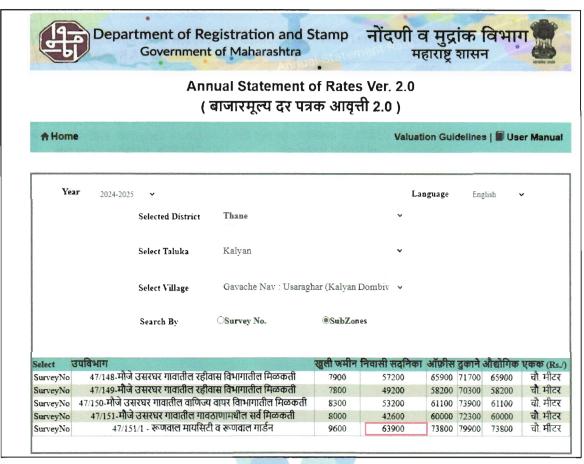
Note: The Blue line shows the route to site from nearest railway station (Dombivli – 6.2 km.)
