- 1) That certificate under Section 270-A of the Bombay Municipal Corporation Act shall be submitted within 3 months.
- 2) That internal access road shall be completed in all respect and completion certificate from Executive Engineer (Road Construction) (Eastern Suburbs) will be obtained within 3 months.
- 3) That conveyance deed will be finalized in the name of Society within 3 months.
- 4) That the Society shall be formed got registered within 3 months.
- 5) That all other Terms and conditions of approved layout under NO. CE/289/BPES/LOT shall be complied with before asking occupation to remaining buildings.
- 6) That dust bin of adequate size shall be constructed within 15 days.

NOTE : This permission is issued without prejudice to the actions under Sections 270-A,305,353-A of Bombay Municipal Corporation Act.

Please also note that if any of the above mentioned objections are not complied with and if the user mentioned in the approved plans is found changed without prior permission from the Municipal Corporation, this occupation certificate granted to your client will be treated as cancelled and steps will be taken to cut off the water connection granted to your client.


