Justification for Price / Rate

The Market Value of the property is based on facts of markets discovered by us during our enguiries, however the government rate value in this case is less than the market value arrived by us. We are of the opinion that the value arrive by us will prove to be correct if an Auction of the subject property is carried out. 






Route Map of the property




