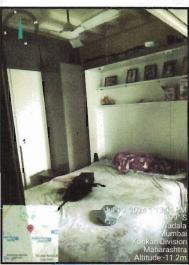

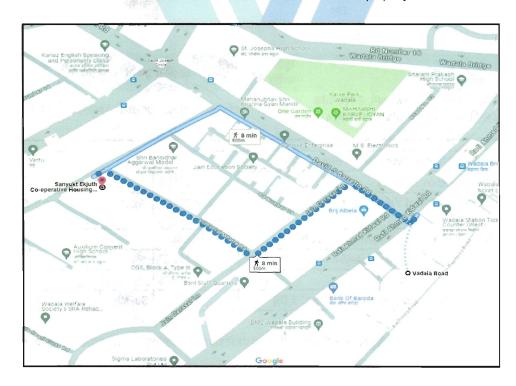




Route Map of the property

Note: The Blue line shows the route to site distance from nearest Railway Station (Wadala Road - 500m).



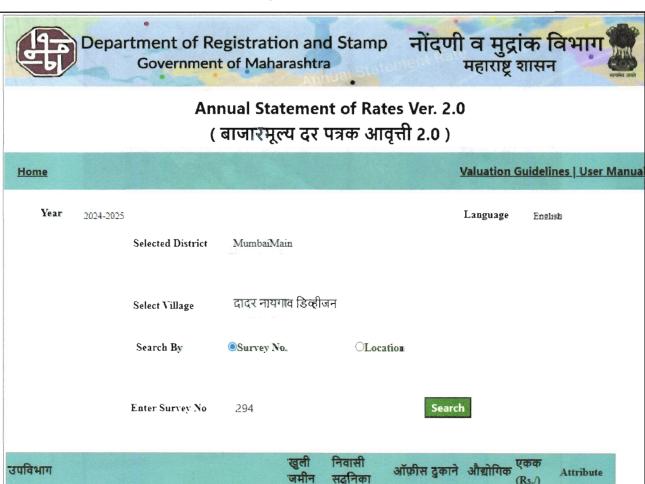
