1. The land vacated in consequence of the endorsement of the commencement certificate/widening line shall form part of the public street
2. That no new building or part thereof shall be occupied or allowed to be occupied or used or permitted to be used by any person until occupation permit has been granted.
3. The commencement certificate/development permission shall remain valid for _____ years commencing from the date of its issue.
4. This permission does not entitle you to develop land which does not lie within the sanctioned plans.
5. This Commencement Certificate is renewable every year but such extension period shall be in no case exceed three years provided further that such extension shall be on any subsequent application for fresh permission under section 44 of the Maharashtra Regional & Town Planning Act, 1966.
6. This certificate is liable to be revoked by the Municipal Commissioner, Greater Mumbai if:
 - (a) The Development work in respect of which permission is granted under this certificate is not carried out or the use thereof is not in accordance with the sanctioned plans.
 - (b) Any of the conditions subject to which the same is granted or any of the restrictions imposed by the Municipal Commissioner for Greater Mumbai is violated and or not complied with.
