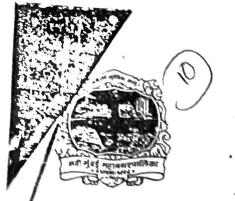

    Provided that the authority may approve the Pain Water harvesting Structures or specifications different from those in schedule, subject to the minimum capacity of Rain Water Harvesting being ensured in each case.
  - b) The owner/ society of every building mentioned in the (a) above shall ensure that the Rair Water Harvesting structure is maintained in good repair for stocage of water for non potable purposes or recharge of groundwater at all times.
  - c) The Authority may impose a levy of not exceeding As. 1000/- per annum for every 100 sq. m of built up area for the failure of the owner of any building mentioned in the (a) above to provide or to maintain Rain Water Harvesting as required under these by elaws.
- The Occupancy Certificate for the proposed building will not be granted unless Sciar Assisted Water Heating System shall perovided as stipulated in Rule No. 35 of D.C.R.-1994: (Copy attached herewith)

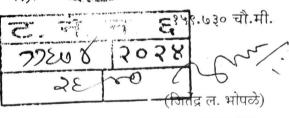

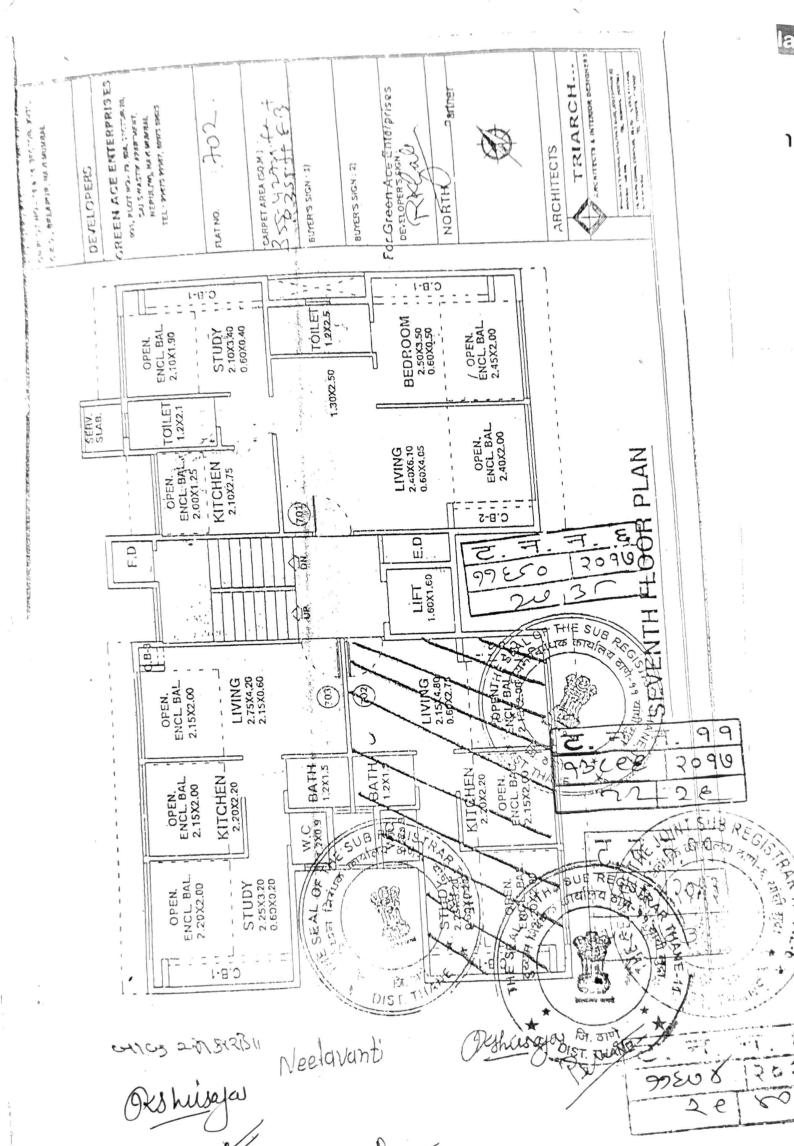
