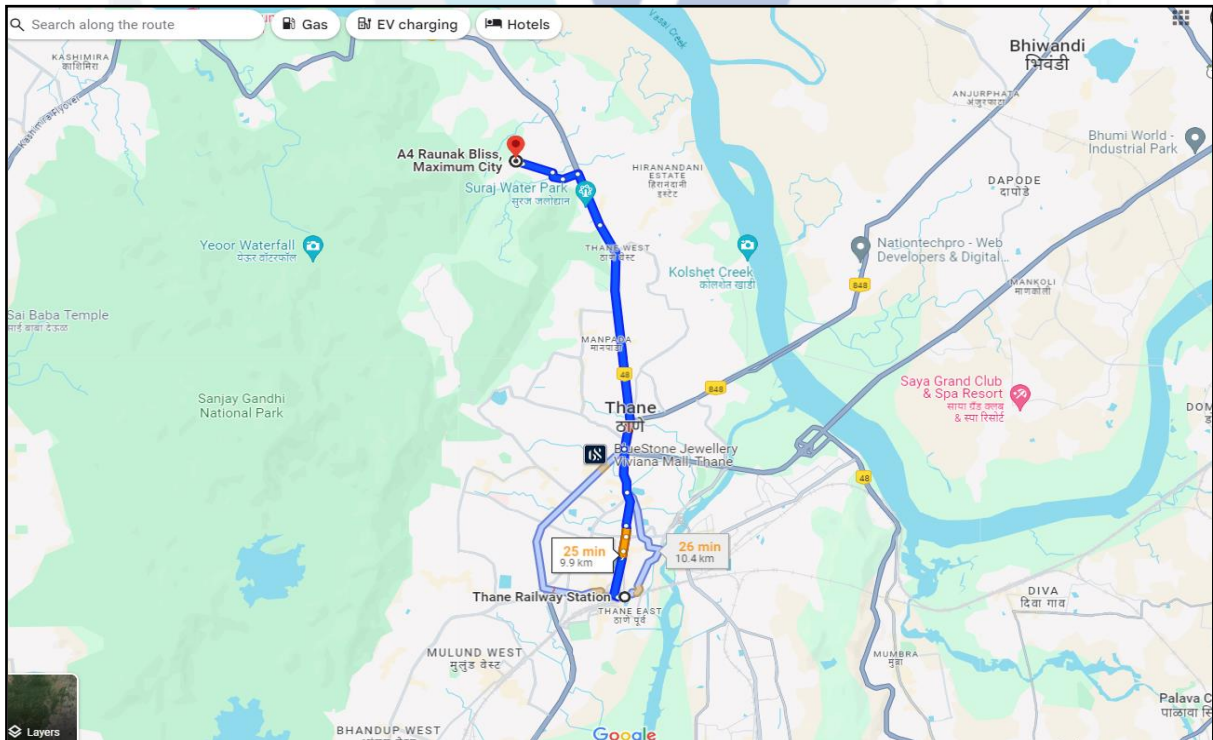
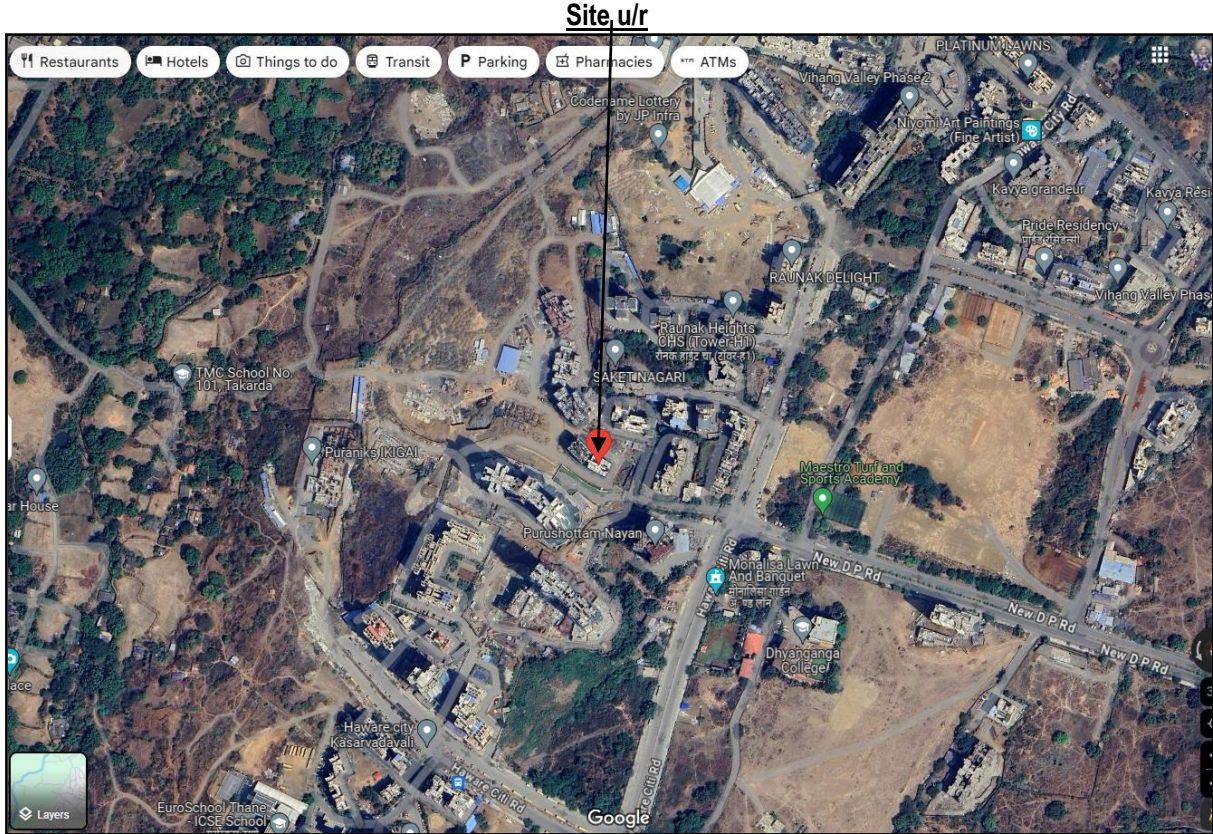



Justification for price / rate
