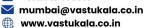








Route Map of the property Site u/r




