(c) The Municipal Commissioner for Greater Mumbai is satisfied that the same is obtained by the applicant through fraud or misrepresentation and the application and every person deriving title through or under nim in such an event shall be deemed to have carried out the development of contravention of section 43 or 45 of the Maharashtra R
