









Route Map of the property

Note: The Blue line shows the route to site from nearest railway station (Thane – 5.6 Km.)









Justification for price / rate

The Market Value of the property is based on facts of markets discovered by us during our enquiries, however the government rate value in this case is less than the market value arrived by us.
