### **AGREEMENT**

THIS AGREEMENT made at Bombay this 3 day of Morf in the Christian Year Two Thousand and Five BETWEEN MESSRS D.K. ### WHEREAS:

a] By an Agreement dated 2<sup>nd</sup> day of September, 1974 as modified by an Agreement ,dated 6<sup>th</sup> December, 1985 and executed between Narottamdas K. Shah and Others
