By direction I have to inform you that the permission to occupy the completed portion of ground and structure shown by you in the red colour in the plan submitted on 30.9.83 is hereby granted. Please note that this permission is without prejudice to action under sec. 253 and subject to following conditions.

1. That the certificate n/s 270A of B.M.C. shall be obtained from A.E.W.W.P/North and a certified copy of the same shall be submitted to this office.
2. That the water supply for premises for which occupation is granted shall be restricted to normal requirements and no complaint for short supply of water shall be entertained in future.
3. That D.I.L.R.'s certificate for encroachment of ownership on setback land in the name of M.C. shall be submitted before B.C.C. or within 6 months.
4. That the compound wall on all sides should be completed in due course.
5. That completion certificate for remaining work of H.W. Drain should be submitted within 6 months.
6. That Co-OP. Society shall be registered within 6 months.
7. That 15% H.C. should be developed along compound thereto within one year.
8. That all the terms and conditions of layout under No. CM/338/LQP shall be complied with.
