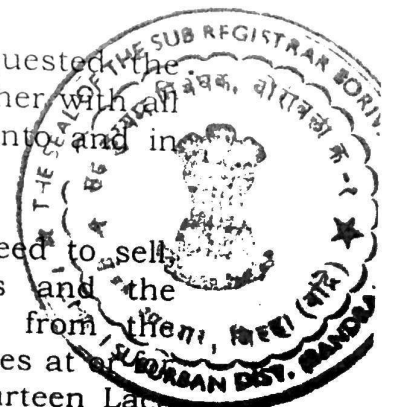

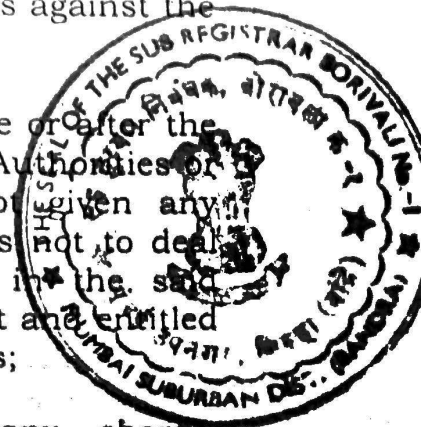
Mumbai - 400 063, more particularly described in the Schedule hereunder written and all the rights and benefits acquired by the Transferor in the said premises together with the benefits of deposit money, sinking fund and the value of the said shares standing to the credit of the Transferor in the books of the society for the total consideration of Rs.14,00,000/- (Rupees Fourteen Lacs Only).

2. 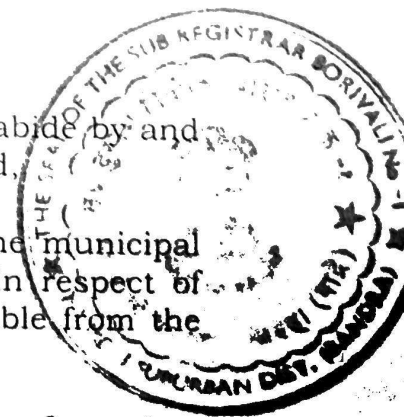

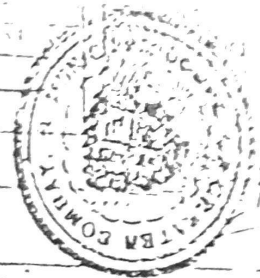

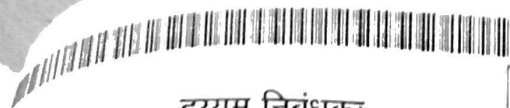
