The revised Commencement Certificate was issued vide letter Ref. No. T.C.P. (P-2) BKC-27(CC)/G/2.13/419/2001 along with amended plans for proposed development on the plot under reference.

With reference to MMRDA's above mentioned letter dated 23/10/2001, the revised Commencement Certificate and the Architect's request for occupation of the Tower no. 3, the building inspection certificate was issued vide letter Ref.
