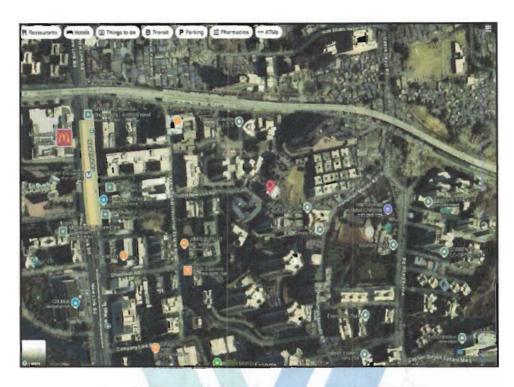








# Route Map of the property

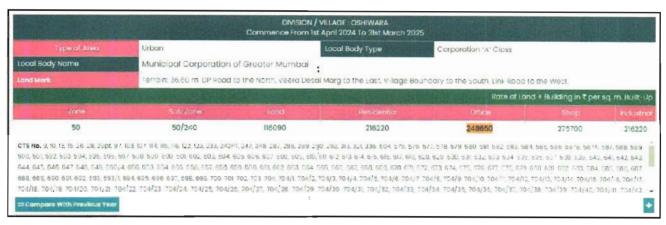
Note: The Blue line shows the route to site distance from nearest Metro Station (Lower Oshiwara - 600 Mtrs.).

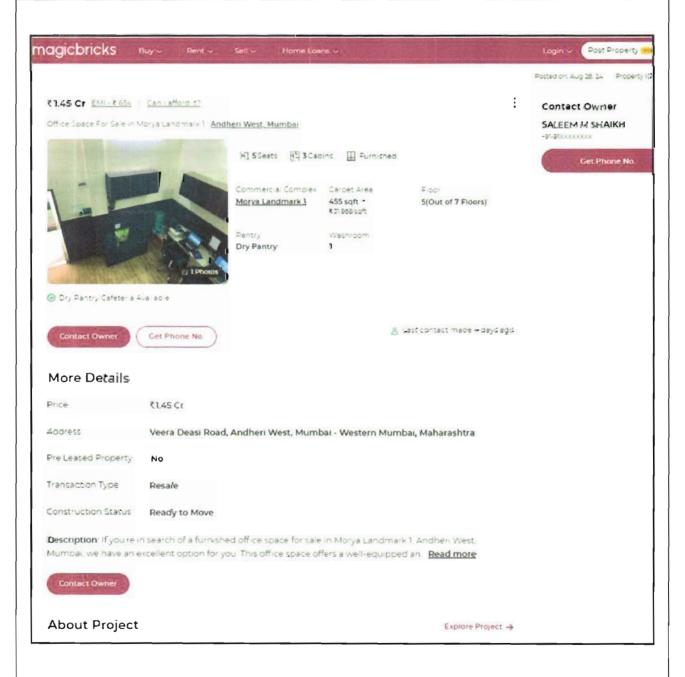

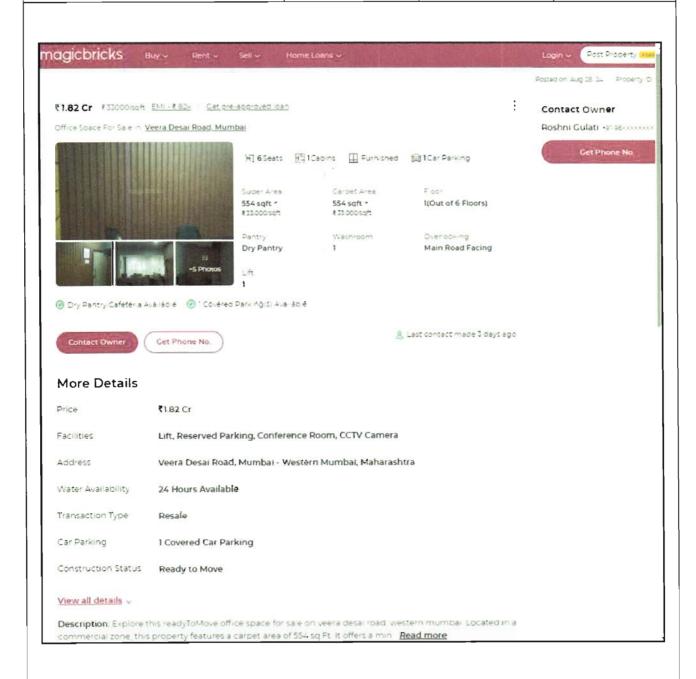
