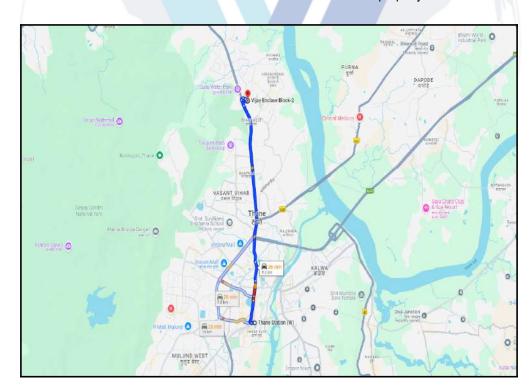




Route Map of the property

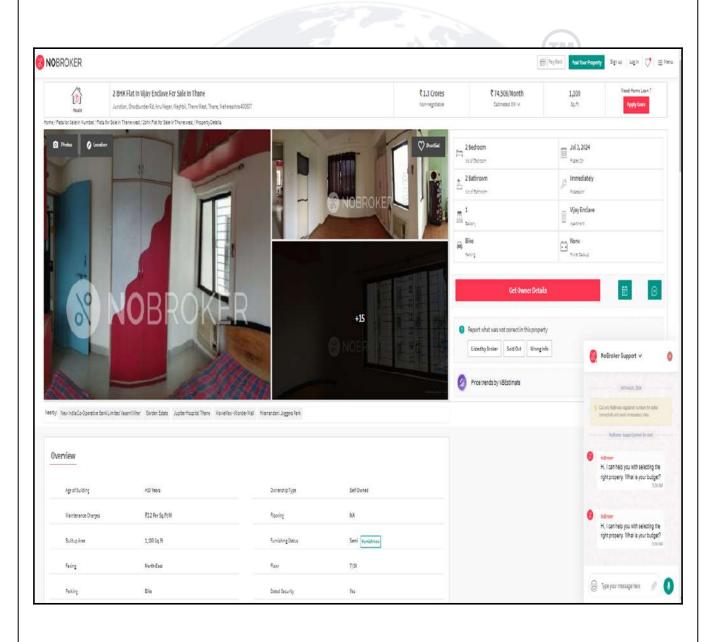

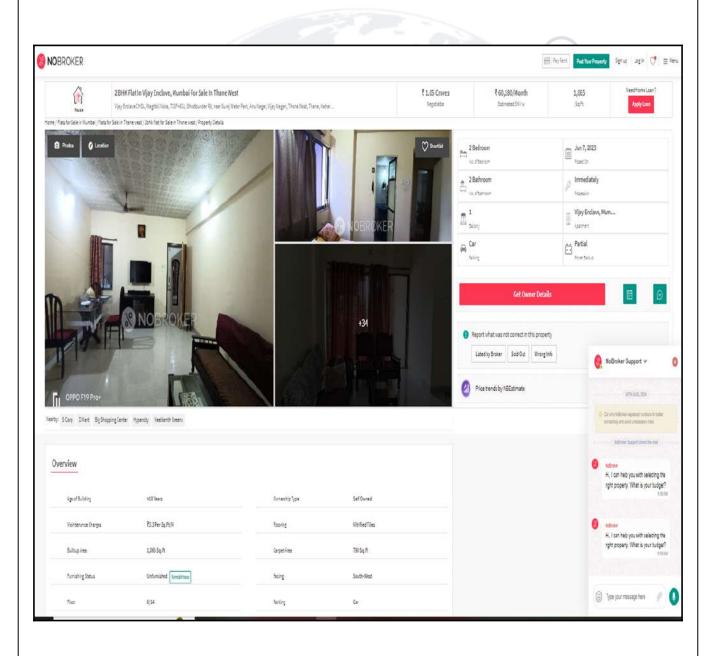
