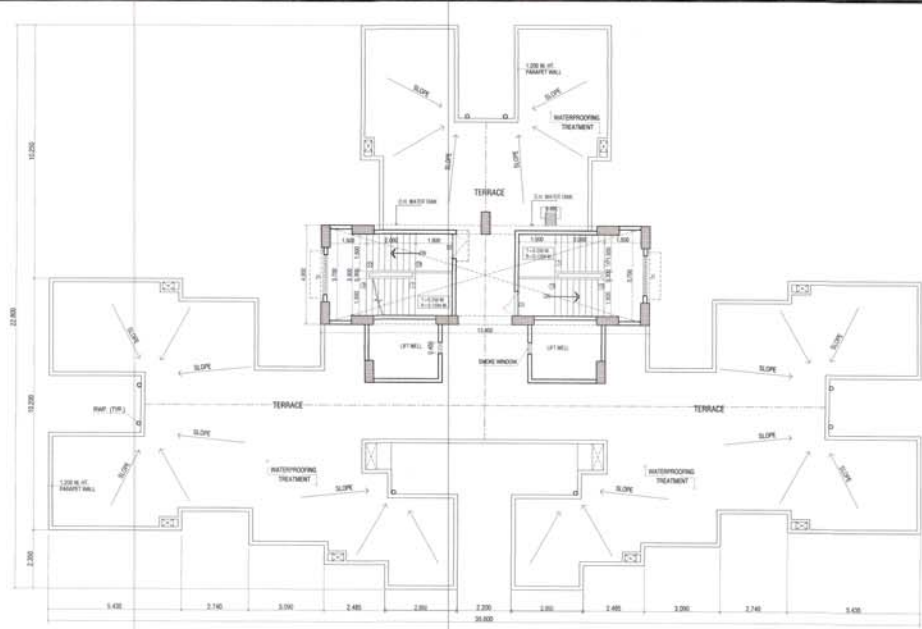

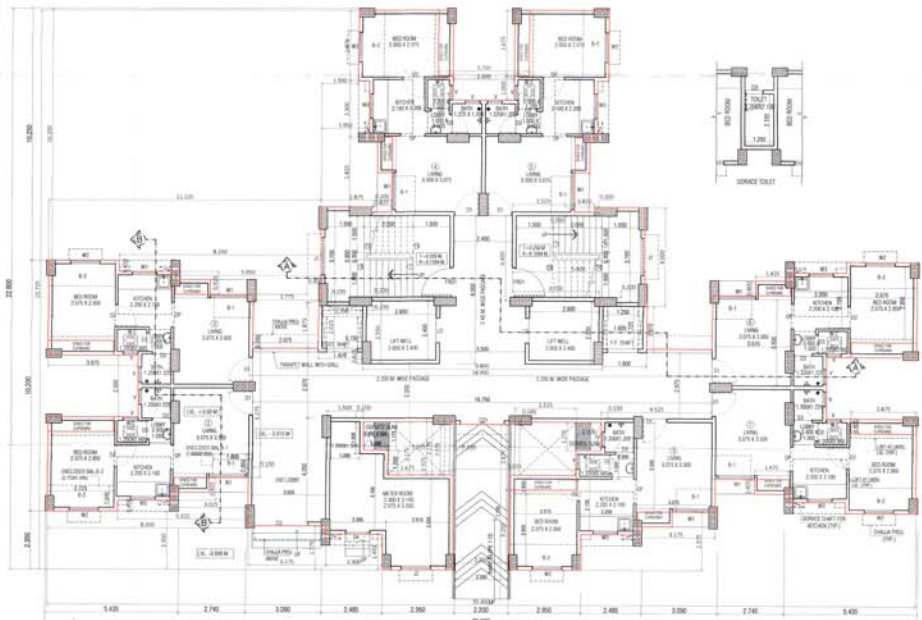

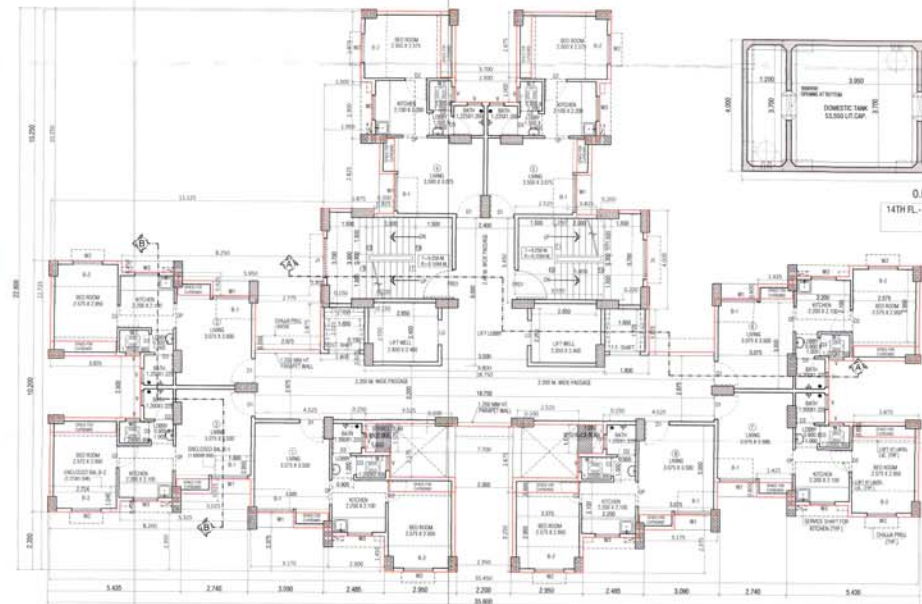
REFUGE FLOOR PLAN EWS(R)
(8th, 10th & 12th fl.)



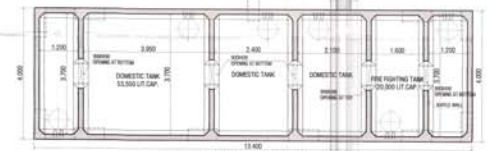
TERRACE FLOOR PLAN EWS(R)
