TYPICAL FLOOR PLAN

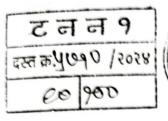

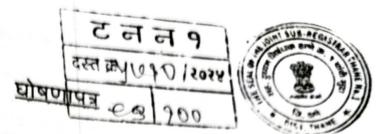
